Sub: Admissibility of Assured Career Progression (ACP) Scheme under RSRTC Employees (Revised Pay) Regulations, 2008.

- 1. The Scheme of Assured Career Progression (ACP), with three financial upgradations, was made applicable with effect from 01.01.2006 under RSRTC Employees (Revised Pay) Regulations, 2008 vide Order No F4(13) Finance/Rules/ 172/2008/8211 dated 17.11.2008 and as further amended vide order No F4(13) Finance/Rules/172/2009/2231 dated 02.04.2009, F4(13) Finance/Rules/172/ 2013/4257 dated 08.07.2013 and F4(13) Finance/Rules/ 172/2013/4474 dated 15.07.2013. Financial upgradation was allowed, under this scheme in the immediate next higher grade pay in the hierarchy of Running Pay Bands and Grade Pays.
- 2. The grade pays, as originally fixed vide order No 8211 dated 17.11.2008 were subsequently changed as per order No 4257 dated 08.07.2013 made effective from 01.07.2013. In view of changes made in running pay band and grade pays vide order No 4474 dated 15.07.2013 prescribed the admissibility of ACPs in the following manner:-
