
**Subject:- Permission for exercise of option/re-option under
RSRTC Employees Revised Pay Regulations, 2017**

The RSRTC Employees Revised Pay Regulation, 2017 have been promulgated with effect from 01.04.2022 vide office order No F4(13)Finance/Rules/175/2022/1276 dated 29.03.2022. The regulation 8 and 9 of these regulations provide for exercise of option within three months.

It has been brought to the notice that some of the Corporation Employees could not exercise option within the time limit prescribed under Regulation 9(1) and in terms of provisions contained in sub-regulation (3)(i) and (4) of Regulation 9, they were deemed to have exercised option for revised pay scales, 2017 w.e.f. 01.04.2022, which might have resulted in a recurring disadvantageous position. Likewise, some of the Corporation employees have exercised option incorrectly without understanding the proper implications of the regulations governing fixation of pay. The exercise of such incorrect option has put them to recurring financial loss.

The matter has been considered sympathetically and The Chairman is pleased to decide that all Corporation employees may be permitted to exercise option/re-option under Regulation 8 and 9 of the aforesaid regulations upto 31st July, 2023. In case of change of earlier option, the excess amount of pay and allowances already drawn on account of fixation of pay under these regulations shall be deposited by the concerned incumbent in lump sum.

These orders are being issued in anticipation of the Corporation Board's approval.
