Sub: Grant of Dearness Allowance to Corporation employees.

The existing rates of Dearness Allowance payable to the corporation employees, under this office order No. F.4(13)/Finance/Rules/52/2014/514 dated 22.01.14 shall be revised with effect from 01.03.2014 in respect of those employees whose pay had not been revised for different reasons or who had excercised an option to continue in the pay scales as contained in the RSRTC employees (Revised pay scales) Regulations, 1998, as under:-

- 1. Out of 61%D.A. sanctioned vide order no. F.4(13)/Acctt./Rules/52/4414/dated 13.05.2004,50% has been treated as Dearness pay w.e.f. 01.07.04 as per this office order No. F.4(13)/ Finance/ Rules/52/2004/5593 dated 14.06.04.
- 2. D.A.@183%as indicated in item (2) of this office order No. F.4(13)/ Finance / Rules/ 52/2014/514 dated 22.01.14 payable on the Total of Basic pay+Dearness pay shall be revised to 200% w.e.f. 01.03.2014.
- 3. The term "Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 7(18) of RSRTC Employees Service Regulations drawn in the Revised Pay Scales prescribed under the RSRTC employees (Revised Pay Scales) Regulations, 1998 and shall not include any other type (s) of pay like special pay or personal pay etc.
- 4. The Payment on account of Dearness Allowance involving fractions of 50 paisa and above may be rounded off to the next higher rupee and the fraction of less than 50 paisa may be ignored.
- 5. The payment of increase in Dearness Allowance under this order shall be admissable in cash from 01.03.2014 i.e.salary for the month of March, 2014 payable on 01.04.2014.
- 6. The decision of increase in Dearness Allowance prior to 01.03.2014 (01.01.2014 to 28.02.2014) would be taken later on.
- 7. The Dearness Allowance of the officers of the Corporation whose pay is drawn on issue of pay slip may also be drawn as per order and no separate pay slip in this regard will be issued.
