**REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTING SERVICES:
MONITORING HERITAGE STRUCTURES FOR JAIPUR METRO RAIL LINE 1 PHASE B
Deadline for Submission of EOI: 14 August 2014 (1500 Hrs. IST)**

1. India has received financing from Asian Development Bank (ADB) under loan 3062-IND for Jaipur Metro Rail Line 1 - Phase B Project and intends to apply a portion of the proceeds to engage a firm of national consultants to monitor heritage structures.
2. The objective is to monitor the condition of heritage structures located along Jaipur Metro Rail Line 1 Phase B underground metro alignment (2.349 kilometers) from Chandpole to Badi Chaupar, during construction and early stages of operation. Requirement details are provided in Terms of Reference.
3. It is estimated that the consulting services will require about 18 national person-months, implemented over 36 calendar months from the commencement date. The estimated cost is about USD 160,000, including survey cost of USD 52,000. A detailed description of the requirements is provided in the outline terms of reference available on ADB website (<http://csr.n.adb.org>) and JMRC website (<https://www.jaipurmetrorail.in/opentender.aspx>).
4. The Executing Agency is the Government of Rajasthan acting through Jaipur Metro Rail Corporation Ltd. (JMRC). The assignment location will be in Jaipur, India.
5. Now, eligible consulting firms are invited to indicate their interest in providing the required services. The EOI may be submitted online through ADB's website as follows:

(1) register with ADB's Consultant Management System at ADB website (<http://www.adb.org>) – Click "About ADB", "Consulting Services", and "Consultant Management System", (2) go to <http://csr.n.adb.org>, (3) click on "India", (4) find captioned project name and click on "View CSRN", (5) click on "Express Interest", and (6) follow the instructions. Important: All requested information must be filled-in completely. The EOI attachments must include Curriculum Vitae (CV) of the proposed expert, as required for Consultant's Qualifications Selection (CQS) method.
6. EOI must be submitted online before **14 August 2014 (1500 Hrs. IST)**. A consulting firm will be selected in accordance with the CQS procedures set out in the ADB Guidelines on the Use of Consultants by the Asian Development Bank and Its Borrowers.
