**NOTICE INVITING QUOTATIONS FOR PHOTOGRAPHY SERVICES**

JAIPUR METRO RAIL CORPORATION LIMITED, JAIPUR invites sealed Quotations for photography Services from well experienced professional agencies/photographers for events and other requirements of JMRC.

The terms and conditions are as under:-

1. The photographer/agency should have experience of professional/ press photography work for at least 3 years. The agency shall submit documents viz experience details & client certificates to substantiate the same.
2. It will be a call based service as per JMRC requirement. Generally 4 calls in a month may be expected.
3. The Photographer/Agency shall be called at any time as per requirement of JMRC and shall be required to report within the time as given by JMRC.
4. The work shall be executed under the supervision of the Public Relations Officer of JMRC or any other person authorized for the same.
5. Reporting point for the photographer shall be at JMRC office or as directed by the Public Relations Officer of JMRC.
6. Photography shall be executed with a professional camera of not less than 16 Mega Pixels with HD video mode facility.
7. The services of photographer/agency include manpower with camera as specified.
8. The photographer/agency shall be expected to conduct self in a well behaved manner while working for JMRC.
9. Although mostly still photographs shall be required, but small duration video clips of up to 10 minutes duration may also be required occasionally.
10. After completion of the work, all photographs/video clips shall be handed over to the Public Relations Officer/other authorized officer JMRC in soft copy. Hard copies of selected photographs shall be supplied as per the demand of JMRC.
11. All photographs/video clips shall be the sole property of JMRC. The photographer/agency shall not be allowed to use these in any form anywhere. Otherwise he/they shall be liable to be prosecuted under the law.
12. The rates are to be quoted in the Bid format annexed herewith.
13. The following slabs will apply to additional hours of photography beyond the first two hours on any given day of work :-

14. The rates quoted shall be inclusive of all expenses, no other charges shall be paid by JMRC. However taxes, if any & quoted in the bid shall be paid extra. TDS shall be deducted as per rules.
15. Completely filled and sealed quotations in the prescribed format along with eligibility documents may be submitted up to 3 PM on 17.04.2015 at the office of General Manager (Admin.), IIIrd floor KhanijBhawan, TilakMarg, Jaipur and the same will be opened at 3.30 PM on the same day.
16. The decision of JMRC shall be final in regard to this invitation.
17. The contract shall be valid up to 31 March, 2016, which may be further extended for a period of one year or part thereof, at the behest of JMRC, depending upon the requirement and administrative convenience of JMRC in mutual agreement with the Agency/Firm. Such extension would be at the same terms and conditions. But JMRC will be free to terminate the contract at any time, if the quality of service rendered by the photographer/agency is not found satisfactory by JMRC.
18. The financial evaluation shall be based on the lowest quote of grand total, as per Sr. No. 5 the Annexed Bid format.
