1 INSTRUCTIONS TO BIDDER

1.1 GENERAL

1.1.1.1 Sealed Bid is invited for the Bid No. JMRC/O&S/RS/2018-19/NIB/002 towards "RATE CONTRACT FOR CALIBRATION OF TESTING AND MEASURING EQUIPMENTS TO BE USED IN ROLLING STOCK" by Jaipur Metro Rail Corporation Limited, hereinafter called the 'Employer', for Works in accordance with this Bid Package. The Bid consist of the following documents, along with their Tables, appendices, addenda, corrigenda and errata if any.

- (i) Notice Inviting Bid
- (ii) Instructions To Bidder (ITT)
- (iii) Special Conditions of Contract (SCC) and Scope of Work
- (iv) Formats forming part of technical bid
- (v) Financial Bid - Bill of Quantities

Bids shall be prepared and submitted in accordance with the instructions given herein. This bid is under RTTP Act 2012 & RTTP Rules, 2013.

1.2 BID DOCUMENTS

1.2.1 CONTENTS OF BID DOCUMENTS

1.2.1.1 The Bidder is expected to examine carefully all the contents of the Bid documents including instructions, conditions, forms, terms, specifications and take them fully into account before submitting his offer. Failure to comply with the requirements as detailed in these documents shall be at the Bidder's own risk. Bids, which are not responsive to the requirements of the Bid documents, will be rejected.

1.3 SUBMISSION OF BIDS

1.3.1 COST OF BID DOCUMENT/EMD AMOUNT

1.3.1.1 The BID should be submitted in the prescribed Bid document, which may be purchased for Rs.118/- (including 18%GST), by Cash or DD/Banker Cheque drawn in favour of Jaipur Metro Rail Corporation Ltd., payable at Jaipur. The complete bid document can also be downloaded from the website <http://transport.rajasthan.gov.in/jmrc> or www.sppp.rajasthan.gov.in. In case the bid document is downloaded from website, the cost of bid document is to be submitted in the form of DD/Banker's Cheque along with the Bid document submitted. The cost of the Bid document is non-refundable.

1.3.1.2 EMD can be deposited in the form of Demand Draft/ Bankers Cheque of Rs 6670/- (Rupees Six Thousand Six Hundred Seventy only) drawn in favour of Jaipur Metro Rail Corporation Ltd., payable at Jaipur, shall form part of the bid.

1.3.1.3 Bid security shall be 2% of the estimated value of subject matter of procurement. In case of Small Scale Industries of Rajasthan it shall be 0.5% of the quantity offered for

supply and in case of sick industries other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the value of bid. (Please refer rule 42 of RTPPR i.e. Rajasthan Transparency in Public Procurement Rules, 2013. Proof of such exemption has to be submitted with the bid document.

1.3.1.4 The Bid Security of unsuccessful Tenderers shall be refunded soon after final acceptance of successful bid and submitting performance security.

1.3.1.5 The Bid Security taken from a bidder shall be forfeited, including the interest, if any, in the following cases, namely: -

- a) when the bidder withdraws or modifies its bid after opening of bids;
- b) when the Tenderer fails to commence the supply of the goods or service or execute work as per supply/ work order within the time specified;
- c) when the Tenderer does not deposit the performance security within specified period after the supply/ work order is placed; and
- d) If the Tenderer breaches any provision of code of integrity, prescribed for Tenderers, specified in the bidding document.

1.3.1.6 Notice will be given to the Bidder with reasonable time before Bid Security (EMD) deposited is forfeited.

1.3.1.7 No interest shall be payable on the Bid Security (EMD).

1.3.1.8 In case of the successful Tenderer, the amount of Bid Security may be adjusted in arriving at the amount of the Performance Security, or refunded if the successful Tenderer furnishes the full amount of performance security.

1.3.1.9 The procuring entity shall promptly return the Bid Security of the successful Tenderer after the earliest of the following events, namely:-

- a) the expiry of validity of Bid Security;
- b) Issue of LOA for procurement and performance security is furnished by the successful Tenderer;
- c) the cancellation of the procurement process; or
- d) The withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.

1.3.2 SEALING AND MARKING OF BIDS



1.3.3 **EVALUATION OF BID**

- 1.3.3.1 The Employer will carry out technical cum financial evaluation of submitted proposals to determine that the Bidder has a full comprehension of the work of the contract. Where a Bidder's technical submittal has a major inadequacy, his Bid will be considered to be non-compliant and will be rejected.
- 1.3.3.2 For price evaluation of bid, the Total Overall Cost as quoted for **"Rate contract for calibration of testing and measuring equipments to be used in Rolling stock"** will be considered. Bidder must have to quote for all the items mentioned in the BOQ(Bill of Quantities). In case, a bidder does not quote for any item, the bid shall be summarily rejected.
- 1.3.3.3 All offers shall be evaluated and marked L1, L2, L3 etc., L1 being the offer which is the overall least expensive offer.

1.3.4 **NEGOTIATIONS**

- 1.3.4.1 Except in case of procurement by method of single source procurement or procurement by competitive negotiations, to the extent possible, no negotiations shall be conducted after the pre-bid stage. All clarifications needed to be sought shall be sought in the pre-bid stage itself
- 1.3.4.2 Negotiations may, however, be undertaken only with the lowest or most advantageous bidder under the following circumstances-
- 1.3.4.3 (a) when ring prices have been quoted by the bidders for the subject matter of procurement; or
- 1.3.4.4 (b) when the rates quoted vary considerably and considered much higher than the prevailing market rates.
- 1.3.4.5 The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.
- 1.3.4.6 The lowest or most advantageous bidder shall be informed in writing either through messenger or by registered letter and email (if available). A minimum time of seven days shall be given for calling negotiations. In case of urgency the bid evaluation committee, after recording reasons, may reduce the time, provided the lowest or most advantageous bidder has received the intimation and consented to regarding holding of negotiations
- 1.3.4.7 Negotiations shall not make the original offer made by the bidder inoperative. The bid evaluation committee shall have option to consider the original offer in case the bidder decides to increase rates originally quoted or imposes any new terms or conditions.

1.3.4.8 In case of non-satisfactory achievement of rates from lowest or most advantageous bidder, the bid evaluation committee may choose to make a written counter offer to the lowest or most advantageous bidder and if this is not accepted by him, the committee may decide to reject and re-invite bids or to make the same counter-offer first to the second lowest or most advantageous bidder, then to the third lowest or most advantageous bidder and soon in the order of their initial standing and work / supply order be awarded to the bidder who accepts the counter-offer. This procedure should be used in exceptional cases only.

1.3.4.9 In case the rates even after the negotiations are considered very high, fresh bids shall be invited.

1.3.5 CORRECTION OF ERRORS

1.3.5.1 Bids determined to be technically acceptable after technical evaluation will be checked by the Engineer/ Employer for any arithmetical errors in computation and summation during financial evaluation. Errors will be corrected by the Employer

1.3.5.2 If a Bidder does not accept the correction of errors as outlined above, his Bid will be rejected and the Bid security forfeited.

1.4 AWARD OF CONTRACT

1.4.1 AWARD CRITERIA

1.4.1.1 Employer will award, the Contract to the Bidder, whose Bid has been determined to be substantially responsive, technically & financially suitable, complete and in accordance with the Bid documents.

1.4.1.2 The "Letter of acceptance" will be sent in duplicate to the successful Bidder, who will return one copy to the Employer duly acknowledged and signed by the authorized signatory, within seven days of receipt of the same by him. No correspondence will be entertained by the Employer from the unsuccessful Bidder.

1.5 SIGNING OF AGREEMENT

1.5.1 The Employer shall prepare the Agreement on non-judicial stamp as per stamp act, in the Performa (Form D clause 3.4) included in this Document, duly incorporating all the terms of agreement between the two parties. Within 30 days from the date of issue of the letter of acceptance, the successful tenderer will be required to execute the Contract Agreement. One copy of the Agreement duly signed by the Employer and the contractor through their authorized signatories, will be supplied by the Employer to the Contractor.

1.5.2 Prior to signing of the Contract Agreement, the successful tenderer shall submit the following documents within a period of 30 days from the date of issue of the Letter of Acceptance:

1.6 PERFORMANCE SECURITY

- 1.6.1.1 Performance security shall be solicited from all successful bidders except the departments of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them.
- 1.6.1.2 The amount of performance security shall be 5% of the amount of contract in case of procurement of services. In case of Small Scale Industries of Rajasthan it shall be one percent of the amount of quantity ordered for supply of goods and in case of sick industries, other than Small Scale Industries, whose cases are pending before the Board of Industrial and Financial Reconstruction (BIFR). It shall be two percent of the amount of supply order.
- 1.6.1.3 The successful Bidder shall furnish to the Employer a security for an amount of 5% of the Contract Price, in accordance with General Conditions of Contract. The Performance Security can be in the form of Bank Draft or Banker's Cheque or a bank guarantee of a Scheduled Bank in the favour of JMRC, Jaipur. The Bank Guarantee has to be from a Scheduled Bank based in India and the Form of Performance Security (Form C clause 3.3) provided in this Volume shall be used. The Performance Security shall be furnished within the time limit specified in Clause 1.5.2
- 1.6.1.4 In case successful Bidder fails to commence the work (for whatsoever reasons) as per terms and conditions of Bid after issuance of LOA then the LOA shall be cancelled and the Performance Security shall be forfeited.
- 1.6.1.5 Performance Security shall remain valid for a period of 60 Days (including guarantee period) beyond the date of completion of all contractual obligations of the Bidder.
- 1.6.1.6 Performance Security will be returned after last calibrated EQUIPMENTS guarantee period expiry.

2 GENERAL CONDITIONS OF CONTRACT & SCOPE OF WORK

2.1 GENERAL

2.1.1 SPECIAL ATTENTION

2.1.1.1 The Contract will be awarded to the Bidder whose responsive Bid is determined to be the lowest evaluated Bid. Clause 1.3.3 of "Instructions to Bidder" may be referred to in this connection.

2.1.2 Completion Period:

2.1.2.1 The Completion period is **two years** from the day of issue of Letter of Acceptance.

2.1.3 Delivery Schedule:

2.1.3.1 All the measuring and testing EQUIPMENTS as per clause 4.1 will be issued to the contract for calibration in **lots** according to availability by JE/RS/CS. The contractor or his authorized representative shall lift the each lot of EQUIPMENTS within two days from the date of intimation and shall return each lot of instrument in good condition duly calibrated along with certificates, within seven days from the date of lifting.

2.1.4 Transportation:

2.1.4.1 The cost of calibration of EQUIPMENTS shall include the cost of transport of EQUIPMENTS Including all incidental arrangements for safe transport of EQUIPMENTS.

2.1.5 Indemnity Bond:


2.1.5.1 Contractor shall submit an Indemnity Bond on non-judicial stamp of value Rs.100/- before start of work as per format given by JMRC for total value of Testing and Measuring EQUIPMENTS for an amount of **Rs. 5 lacs**. This bond will be for the safe custody of JMRC materials at the firm's premises.

2.1.6 Variation in quantity:

2.1.6.1 Quantity of EQUIPMENTS offered for calibration may vary as per site requirement/availability and performance at same rate as accepted by JMRC, and this shall be at sole discretion of the procuring entity.

2.1.7 Calibration tag/sticker:

2.1.7.1 Each instrument must be identified with a suitable sticker having following details:

2.1.8 Calibration and Traceability certificate:

2.1.8.1 Calibration report of each instrument to be supplied in detail for each range. Traceability certificate of National and International level Lab for each calibrated instrument shall be supplied along with calibration report. Each calibrated instrument satisfies the requirement of ISO 17025(NABL) certified laboratory.

2.1.9 Inspection of EQUIPMENTS after calibration:

2.1.9.1 Inspection of EQUIPMENTS shall be done by the authorized representative of JMRC after receipt of the EQUIPMENTS in Mansarovar Depot, duly calibrated, supported by the certificate /traceability of National and International level.

2.1.10 Acceptance Certificate:

2.1.10.1 After the conclusion of inspection and test to the satisfaction of the JMRC representative and receipt of the same in good condition at Mansarovar Depot, an acceptance certificate of EQUIPMENTS received will be signed jointly.

2.1.11 Guarantee period:


2.1.11.1 The calibration of calibrated EQUIPMENTS shall be guaranteed by the contractor for a period of 12 months from the date of receipt and acceptance by the JMRC. The contractor shall give the guarantee that the EQUIPMENTS calibrated with traceability to National and International level Lab and satisfy the requirement of ISO 17025 (NABL) and if found any deviation at the time of inspection or guarantee period the contractor shall recalibrate the same EQUIPMENTS as per requirement at free of cost.

2.1.12 Liquidated damage (Penalty):

2.1.12.1 If the contractor fail to achieve the target for calibration of instrument within contract period. Liquidated Damages shall be as follows:-

- a. For delay upto 25% period of actual delivery period (ADP)- 2.50% of the rate of calibration of particular instrument.
- b. For delay upto 50%period of actual delivery period (ADP) - 5.00% of the rate of calibration of particular instrument.
- c. For delay upto 75%period of actual delivery period (ADP) - 7.50% of the rate of calibration of particular instrument.
- d. For delay upto 100%period of actual delivery period (ADP) - 10.00 % of the rate of calibration of particular instrument.

2.1.13 **Payment:**


- 2.1.13.1 Payment will be made on actual work executed after satisfactory completion of work.
- 2.1.13.2 No advance will be payable.
- 2.1.13.3 Bills, correct in all respect, shall be submitted in the favour of JMRC, Jaipur with bank details in duplicate along with the acceptance certificate and relevant documents, if any, for arranging payment.

2.1.14 **Other conditions:**


- 2.1.14.1 Prices are inclusive of manpower, tools, transportation, all taxes & duties etc.
- 2.1.14.2 No T&Ps shall be issued to contractor.
- 2.1.14.3 Only authorized staff of contractor having proper identity card issued by the contractor/firm shall be permitted to enter in JMRC Mansarovar depot.
- 2.1.14.4 The work should be carried without causing any hindrance to the users.
- 2.1.14.5 If the contractor fails to perform satisfactorily, the contract may be terminated at any time without assigning any reason to the contractor.
- 2.1.14.6 The JMRC shall have the right to make minor alterations/additions/substitution in the scope of work or issue instructions that may be deemed necessary during the period of the contract and contractor shall carry out the work in accordance with the instructions which may be given to him by authorized JMRC's representative.
- 2.1.14.7 JMRC representative may inspect the calibration of these EQUIPMENTS at firm's premises.
- 2.1.14.8 JMRC's General conditions of contract shall be applicable.

2.1.15 **Price fall clause**

- 2.1.15.1 The prices under a rate contract shall be subject to price fall clause. A clause regarding price fall shall be incorporated in the terms and conditions of rate contract. Price fall clause is a price safety mechanism in rate contracts and it provides that if the rate contract holder quotes / reduces its price to render similar goods, works or services at a price lower than the rate contract price to anyone in the State at anytime during the currency of the rate contract, the rate contract price shall be automatically reduced with effect from the date of reducing or quoting lower price, for all delivery of the subject matter of procurement under that rate contract and the rate contract shall be amended accordingly. The firms holding parallel rate contracts shall also be given opportunity to reduce their price by notifying them the reduced



price giving them fifteen days time to intimate their acceptance to the revised price. Similarly, if a parallel rate contract holding firm reduces its price during currency of the rate contract, its reduced price shall be conveyed to other parallel rate contract holding firms and the original rate contract holding firm for corresponding reduction in their prices. If any rate contract holding firm does not agree to the reduced price, further transaction with it, shall not be conducted.

3. We undertake, if our Bid is accepted, to commence the works as per date mentioned in "order to commence", of issue the procuring entity 'order to commence' and to complete the whole of the Works comprised in the Contract up to 12 months calculated from the date of issuance of LOA, as indicated in the Appendix.
4. If our Bid is accepted, we will furnish at our option a Bank Guarantee for Performance as security for the due performance of the Contract. The amount and form of such guarantee or bond will be in accordance with General Conditions of the Contract and as indicated in the Appendix.
5. We have independently considered the amount as per the General Conditions of Contract as liquidated damages and agree that they represent a fair estimate of the damages likely to be suffered by you in the event of the work not being completed in time.

(1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under Para (1) shall deal with the appeal as expeditiously as possible and shall endeavor to dispose it within thirty days from the date of the appeal.




