The Bank shall pay to the Employer any money so demanded notwithstanding any dispute/disputes raised by the Contractors in any suit or proceedings pending before any Court, Tribunal or Arbitrator/s relating thereto and the liability under this guarantee shall be absolute and unequivocal.
