

**TERMS OF REFERENCE
FOR HIRING THE SERVICES FOR SCRUTINY OF CLAIM
SUBMITTED BY M/s CEC IN THE ARBITRATION
TRIBUNAL
FOR JAIPUR METRO RAIL CORPORATION LTD.**

1. BACKGROUND & OBJECTIVES

M/s CEC has submitted prolongation claim for the period 15.10.2016 to 15.03.2020 amounting to Rs. 171.44 crore. In this claim M/s CEC divided basic cost of Rs. 141.22 crore in four heads. Presently this claim is under Arbitration proceeding. We need to scrutinize the statement of claim submitted by M/s CEC in detail to present the case before Arbitration.

2. SCOPE OF WORK

- To scrutiny the documents submitted by M/s CEC in the prolongation claim.
- As required by the AAG/Assistant of AAG (Lawyer) of JMRC dealing with the Case before the Arbitral Tribunal, the questions needs to be framed in respect of the claim, based on the expert scrutiny of the documents submitted by the claimant.
- To discuss the related matters with the Lawyers/Officers of JMRC in person by visiting their office for preparation of replies/questions in respect of the said claim.
- Provide other assistance and professional services in respect to the claim as may be required by JMRC in this regard.
- To visit the place of hearing (as & when required) along with the JMRC representative and the Lawyers of JMRC in relation to the hearing.
- To render any other similar professional advice in this matter

3. COMPLIANCE OF RTPP ACT, 2012 & RULES 2013

The bidder is advised to read RTPP Act, 2012 & Rules 2013. He is expected to comply with the provision of the Act & Rules.

4. TERMS OF PAYMENT

1. 50% of total professional fees plus applicable GST will be paid after submission of detailed scrutiny report and questionnaire.
2. Balance 50% of total professional fees plus applicable GST will be paid as follows:-
 - 20% of balance 50% of professional fees plus applicable GST on each hearing
 - Remaining 20% of balance 50% of professional fees plus applicable GST will be paid after final decision of Arbitration Tribunal in this case.


3. The Corporation by written notice may, suspend/forfeit all payment if Professional (CA Firm) fails to perform any of obligations assigned to him.

5. OTHER TERMS AND CONDITIONS

- The proposal should be valid for a minimum period of sixty (60) days from the last date for submission.
- Kindly note that JMRC is entitled to amend any RFP conditions, validity period, specifications, or extend the closing date and/or time of RFP before the last date for submission of proposal.
- JMRC reserves the right to verify any information contained in a proposal.
- JMRC reserves the right not to accept the proposal without assigning any reason thereof.
- The bidder should not be debarred / blacklisted, at the time of bidding.
- JMRC will reimburse the travelling and accommodation expenses for attending the arbitration hearing out of Jaipur on actual basis.




