2. The rates of the items shall be quoted for per paper Ream for all the above items (part bid for any 1 or 2 items will not be considered).
3. The Rate contract will be valid for one year from the issue date of LOA and further extendable upto 03 months on the same price.
4. Either the registered office or the functional branch office of the bidder should be situated in Jaipur.
5. The rates quoted shall be FoR destination and, inclusive of all expenses. No other charges shall be paid extra by JMRC. Taxes if applicable and if quoted extra, shall be paid by JMRC.
6. Supply order shall be issued as per requirement in parts during the contract period. The material is to be supplied within 7 days of issue of purchase order failing which a penalty of Rs. 200 per day of delay shall be imposed.
7. Product specification (as mentioned above) certificate along with samples will be required to be produced by the bidder for the quoted brand item/ offered items along with the bids.
8. Evaluation will be on the basis of the total price of estimated quantities quoted in S.No.6 of annexure-A. Work shall be awarded to the lowest bidder.


