1.1 GENERAL

1.1.1 Jaipur Metro Rail Corporation Ltd. (JMRC) invites offline bids from interested and eligible Scheduled commercial Bank for "Traffic earning, cash collection and coin supply work at each station of Jaipur Metro Rail Corporation Ltd." *on daily basis other than Sundays and Bank Holidays.*

1.1.2 The Bid documents consisting of Specifications, Schedule of quantities of work to be done and set of terms and conditions of contract to be complied with by the contractor, whose Bid may be accepted and all other information/documents pertaining to the work will be open for inspection for Bidders and can be had from the Office of DGM (Operations), Jaipur Metro Rail Corporation Ltd., 418, Admin Building, Mansarovar Depot, Bhriugu Path, Mansarovar, Jaipur – 302020 between 11:00 Hrs to 16:00 Hrs on every working day except on Saturday, Sunday and Public Holidays during the period as mentioned in NIB. To purchase the Bid document, bidder needs to apply on its letter head to GM (Operations), JMRC, Jaipur along with the Cost of Bid form as mentioned at 1.2 (d) of the NIB.

The complete bid document can also be downloaded from corporation's website www.transport.rajasthan.gov.in/jmrc or state procurement portal i.e., www.sppp.rajasthan.gov.in. The bidder can use this downloaded Bid Document for submission. However while submitting of the downloaded bid; bidder shall have to submit the cost of bid form (as per the 1.2 (d) of the NIB) by Demand Draft/ Bankers Cheque in favour of JMRC payable at Jaipur.

1.1.3 Please note that a pre-bid meeting of prospective bidders is scheduled as per the details specified below. The objective of this meeting is to address the queries of the prospective bidders related to the Work/ Bidding document.
