3 Special Conditions of Contract (SCC):-

1. Bidder should have valid GST registration no. and enclose GST Registration certificate with bid document.
2. Performance Security- The amount of performance security shall be five percent of the amount of purchase order in the form of Demand draft/Banker's Cheque or Bank Guarantee from any scheduled bank in favour of Jaipur Metro Rail Corporation Ltd within 30 days from the date of issue of purchase order (Rule 75 of RTPPR -2013). 3. Performance security (Bank Guarantee) shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the bidder, including warranty obligations and maintenance and defect liability period. (Rule 75 of RTPPR -2013)
