

## **OFFENCES AND PENALTIES FOR PUBLIC & PASSENGERS**

### **Provisions under the Metro Railways (O&M) Act, 2002**

<b>SECTION</b>	<b>OFFENCE</b>	<b>PENALTY</b>
59 (1)	<b>Drunkenness or nuisance or act of indecency or interfering in any way with the comfort of any passenger of metro railway</b>	Fine upto ₹ 500 and forfeiture of paid fare or removed from carriage
60 & 30 (1)	<b>Taking or causing to take offensive material upon metro railway</b>	Fine upto ₹ 500 and liability for any consequent loss, injury or damage
61 & 30 (1)	<b>Taking or causing to take dangerous material upon metro railway</b>	Imprisonment upto 4 years with fine upto ₹ 5000 and liability for any consequent loss, injury or damage
62	<b>Demonstration of any kind and pasting posters, writing or drawing anything in the compartment, carriage or premises</b>	Removal from compartment/carriage/ premises and imprisonment upto six months or fine upto ₹ 1000 or both
63	<b>Travelling on roof, etc., of a train</b>	Removal from train and imprisonment upto one month or fine upto ₹ 50 or both
64 (1)	<b>Unlawfully entering or remaining upon metro railway even when requested to leave</b>	Imprisonment upto three months or fine upto ₹ 250 or both.
64 (2)	<b>Walking on metro track without lawful authority</b>	Imprisonment upto six months or fine upto ₹ 500 or both.
67	<b>Obstructing running of train, etc. by squatting, picketing or interfering in any manner</b>	Removal from train/ premises and imprisonment upto 4 years or fine upto ₹ 5000 or both.
68	<b>Obstructing metro railway official in his duties</b>	Imprisonment upto 1 year or fine upto ₹ 1000 or both
69	<b>Travelling without proper pass or ticket or beyond authorised distance</b>	Pay excess charge of ₹ 50 plus ordinary single fare from the Station, the train originally started or unauthorized journey is made. If one fails/ refuses to pay the same on demand, the Metropolitan Magistrate may order it to be recovered in the form of a fine and order imprisonment upto one month in default of payment.
70	<b>Interfering with means of communication in a train or misuse of alarm bell of the train</b>	Imprisonment upto 1 year or fine upto ₹ 1000 or both
71	<b>Altering or defacing or counterfeiting pass or ticket</b>	Imprisonment upto six months
72	<b>Defacing or pulling down public notices put up by metro railway</b>	Imprisonment upto two months or fine upto ₹ 250 or both
73	<b>Unauthorized sale of articles on metro railway train or premises</b>	Fine upto ₹ 500 and in default of payment of fine, imprisonment upto six months.
74 (1)	<b>Maliciously wrecking a train or causing sabotage with the intent of endangering safety of any person</b>	Imprisonment for life or rigorous imprisonment upto 10 years.
74 (2)	<b>Maliciously wrecking a train or causing sabotage with the intent to cause the death or bodily injury likely to cause the death of any person.</b>	Penalty of death or imprisonment for life.

75	<b>Unauthorised sale of tickets</b>	Imprisonment upto three months or fine upto ₹ 500 or both; and forfeiture of tickets.
76	<b>Maliciously throwing anything on a train with the intent of hurting or attempting to hurt persons travelling by metro railway</b>	Imprisonment for life or upto 10 years
77	<b>Endangering safety of persons travelling by metro railway by rash or negligent act or omission</b>	Imprisonment upto 1 year or fine or both
78	<b>Causing damage to or destruction of certain metro railway properties like track, rolling stock, equipments, systems, installations and station buildings etc.</b>	Imprisonment upto 10 years
79	<b>Endangering the safety of persons travelling by metro railway or obstructing any rolling stock by wilful act or omission</b>	Imprisonment upto 7 years
80	<b>Making a false claim for compensation from metro railway administration</b>	Imprisonment upto 3 years or fine or both

1. Station Controllers are authorized to impose penalties of fine, recovery, forfeiture and removal on any person(s) committing any of the offences mentioned above in the Jaipur Metro Rail premises, which includes the entire station premises and metro trains.
2. Depot Controllers are authorized to impose these penalties on any person(s) committing any of the offences mentioned above in the Mansarovar Depot of Jaipur Metro, which includes the entire Depot premises and metro trains.
3. Station Controllers of Mansarovar and Sindhi Camp Stations are authorized to impose these penalties on any person(s) committing any of the offences mentioned above respectively in the entire premises of Mansarovar and Sindhi Camp Receiving Sub Stations of Jaipur Metro.
4. Station Superintendents, Commercial Inspector, Manager (Operations), Manager (Train Operations) & Manager (Commercial) are authorized to impose these penalties on any person(s) committing any of the offences mentioned above in the metro trains of Jaipur Metro.

In case any offender does not pay the fine/comply with the penalty as imposed by any Jaipur Metro official hereby authorized or the penalty of imprisonment is sought to be awarded in lieu of or in addition to fine, the above Jaipur Metro officials will be authorized to detain the offenders and hand them over to the Police for producing them before the judicial authorities.
