ORDER

Jaipur, Jan. 8, 2016

No. F.7(366)Pari/Rules/Hq./HSRP/2011 – Whereas the Government of India (Ministry of Road Transport and Highways), found it necessary and expedient in the public interest to notify certain standards in respect of the new system of High Security Registration Plates (HSRP) for Motor Vehicles and the process used by a manufacturer or vendor for manufacture, supply and affixation of such plates, has amended Rule 50 of the Central Motor Vehicles Rule, 1989 and has issued the order in this respect vide notification G.S.R. 221 (E) dated 28th March, 2001 and subsequent notification No. S.O. 814 (E) dated 22nd Aug., 2001 and S.O. 1041 (E) dated 16th Oct., 2001.

In pursuance of sub-clauses (x), (xc) and (xi) of clause 4 of the Motor Vehicles (New High Security Registration Plate) Order, 2001 and the directions of the Hon'ble Supreme Court the State Government had authorized M/s Real Mazon Rajasthan Pvt. Ltd. to manufacture, supply and affix High Security Registration Plate of such specifications as are prescribed in rule 50 of the Central Motor Vehicles Rules, 1989 in the State of Rajasthan in respect of all categories of motor vehicles (inclusive of already registered and newly registered).

The State Govt hereby allows and directs M/S Real Mazon Rajasthan Private Ltd. to affix high Security Registration Plates on old vehicles registered prior to **15th July 2012**. All vehicles which are registered before **15th July 2012** shall now be required to affix High Security Registration Plates within such time and in a manner as may be decided by orders to be issued in this regard from time to time by the Transport Commissioner. The High Security Registration Plates shall be affixed on vehicles in the premises of the Regional Transport Offices/District Transport Offices, registering authority authorized by the department or the premises designated for this purpose in the State of Rajasthan.

The prescribed rates as per annexure-A are chargeable from vehicle owners and are to be paid directly to M/s Real Mazon Rajasthan Pvt. Ltd. by the vehicle owners. The rates are inclusive of all taxes and levies.
