Subject:- Delegation Of powers by State Transport Authority to Secretary, RTA of respective regions posted as Regional Transport Officer.

Whereas it is considered necessary in public interest to delegate some of the powers of State Transport Authority to Secretary, RTA of respective regions posted as Regional Transport Officer under sub-section (5) of section 68 of the Motor Vehicles Act, 1988 read with rule 5.4 of Rajasthan Motor Vehicles Rules, 1990.

It is, therefore resolved to delegate the following powers of State Transport Authority to Secretary, RTA of respective regions posted as Regional Transport Officer.

- 1. To receive applications related to notified routes pertaining to :-
 - (i) Grant and renew stage Carriage permits under section 71, 72, 81 & 87 of the Motor Vehicles Act, 1988.
 - (ii) Sub-section (3) of section 80 of Motor Vehicles Act, 1988.
 - (iii) Transfer of permit under sub-section (2) of section 82 of the Motor Vehicles Act, 1988.
 - (iv) Replacement under section 83 of the Motor Vehicles Act, 1988.
- 2. To receive applications related to Inclusion of Notified & Non-notified routes under Section 71,72, 80(3) and 81 of the Motor Vehicles Act, 1988.
- 3. To receive applications related to non-notified routes beyond RTA's competence;
 - (i) Grant and renew stage Carriage permits under section 71, 72 & 81 of the Motor Vehicles Act, 1988.
 - (ii) Sub-section (3) of section 80 of Motor Vehicles Act, 1988.
 - (iii) Transfer of permit under sub-section (2) of section 82 of the Motor Vehicles Act, 1988.
- 4. To decide matters connected with time table and fare chart of the vehicles.
- 5. To do all ministerial act on the behalf of State Transport Authority including issuance of permit and to make endorsement of any grant.

While exercising above delegated powers:-

- (i) The Secretary, RTA shall entertain application only which contain the major portion of proposed route/routes length lying in their respective regional jurisdiction.
- (ii) The Secretary, RTA shall ensure that at the time of issuance of permit or making any endorsement on a permit issued by him the vehicle is registered in the name of the applicant.

The Secretary, RTA while granting time table for plying of stage carriage the following running hours (including halting time) should be observed in the interest of the travelling public:-

- (a) For other than ordinary Bus service -55 K.M. in one hour (+/-5 minute) (A.C./deluxe/Semi deluxe/sleeper coach)
- (b) For express service 45 K.M. in one hour (+/-5 minute)
- (c) Other than above (local) service 35 K.M. in one hour (+/-5 minute)
- (iii) The time table for Sleeper Coach shall be granted in such a way that the journey begins not before 6.00 PM and ends not later than 8.00 AM.
- (iv) The Time table for ordinary bus shall be granted in such a way that the journey begins not before 4.00 AM and ends not later than 10.00 PM.
- (v) No stage carriage permit shall be issued for a vehicle having seating capacity less than 37 including driver and conductor.
- (vi) The Secretary, RTA shall ensure the compliance of all directions given by the State Transport Authority from time to time and of all provisions of Motor Vehicles Act and Rules made thereunder.
