

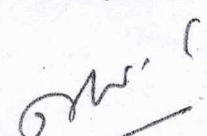

Office Order

1. The existing rate of Dearness Allowance payable to the Corporation employees, drawing pay in RSRTC employees (Revised pay scale) Regulations, 2017 under this office order No F4(13)/Fin./ Rules/52/2025/5509 dated 10.12.2025 shall be revised from 58% to 60% w.e.f. 01.01.2026.
2. The term "pay" for the purpose of calculation of Dearness Allowance shall be the basic pay i.e. total of pay in running pay band and grade pay drawn and shall not include any other type(s) of pay like special pay or personal pay etc.
3. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
4. The amount of increase in Dearness Allowance for the period from 01-01-2026 to 30-04-2026 shall be credited to the GPF/GPF SAB Account as per Provisions of RSRTC Employees GPF Regulation 1989 as under :-
 - (i) For the Employees who are covered in Rule 8 of RSRTC Employees GPF Regulation 1989- in their GPF Account.
 - (ii) For the Employees who are covered under Rule 8A of RSRTC Employees GPF Regulation 1989-in their GPF-SAB Account.
 - (iii) For other employees who are not covered in (i) and (ii) above, Arrears shall be Paid in cash.
5. Cash payment shall be admissible from 01-05-2026 i.e. salary for the month of May, 2026 payable on 01-06-2026.

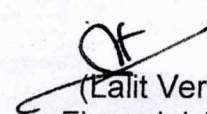
