



TENDER'S TERMS AND CONDITIONS

1. Tenders along with the sample must be enclosed in properly sealed envelope Tender will not be finalized without sample. However, for spare of makes suitable for OE fitment or standard make, relaxation in samples shall be given.
2. Tenderer must deposit earnest money amounting to Rs 8,000/- (Rs.Eight Thousand Only) in cash, bank draft in favour of Chief Production Manager, CWS, RSRTC, Jodhpur. No interest shall be payable on such deposit tender without earnest money shall not be considered.
3. Tenders should mention clearly the rates of each item both in words and in figures and also tax inclusive.
4. Only authorized dealers/distributors of spare parts/ items approved or OE fitment can give approved lists and their discounts structures in the tender, rest of the parties should mention the clear rates and make against each item.
5. The tenderer whose tender is accepted, shall arrange the supply within 24 hrs on placing the order.
6. The rates shall be valid for a period of one year from the date of finalizing the tenders. And it may be extended upto three months with prior notice to the successful tenderer.
7. Terms and conditions duly signed by the tenderer should be returned along with the tender in original.
8. The authorized dealers/distributors/OE manufacturers should submit the certificate of authorisation along with the current price list of their principals or their agency along with the tender form, without which their tenders shall not be accepted.



9. The tenderer should sign the tender form at the end of first and last page as his acceptance of all terms and conditions of the tender. He should also sign every page of the list on which the rates are quoted. Any correction every writing should also be signed by the tenderer.
10. GST registration number should be submitted along with the tender, without which tender is liable to be rejected.
11. In any case if prices of materials/goods included in tender fall due to market behaviour, successful tenderer will be bound to supply the goods/materials on reduced rated. In vice-versa case successful tenderer will continue to supply at rates finalized in DRC. Not in any case successful tenderer will sale material/goods included in DRC to any other party at rates lower than DRC rates.
12. Tender shall be received up to 01.00 p.m. on 30.12.2024 and shall be opened on the same date at 02.30 p.m. in the presence of the Tenderers who are likely to be present at the time of opening.
13. RSRTC reserves the rights to reject any tender/ all tenders at any time without assigning any reason.
14. In case of any dispute the decision of the undersigned shall be final.
15. The firm / party shall be bound to make supply of the materials within 24 hrs of its demand, otherwise responsible for compensating the amount of difference if any, which may arise due to alternative arrangement shall be charged from the party/firm.
16. Items will be colleted by the coporation itself but If the firm/supplier's shop is situated at a place out of approach from conveyance point of view, then supplier himself has to make arrangement for supply at a convenient place at main road.
