- 2. Repairing work will be carried out on firms workshop/service centre in presence of our representative.
- 3. If Radiator fail after fitting in vehicle then it will repair again by firm free of cost.
- 4. In case of any accident occurring during the work, the firm will himself be responsible for any loss/injury caused to the person of form. The corporation will not be liable for any compensation.
- 5. If during work any kind of damage is occured to machine, spare parts, tools etc. then the concerned firm / person will be responsible for it and will have to pay the compensation.
- 6. Any individual who fulfill requirements required for above can participate in this tender.
- 7. The rate should be valid for a period of 12 months from the date of opening of tender. The work will be carried out as per requirements in phased manner. The time could be extended as per requirement on same rates, terms and conditions.
