REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTING SERVICES: PLANNING FOR JAIPUR METRO RAIL LINE 2

1. India has received financing from the Asian Development Bank (ADB) under loan 3062-IND for Jaipur Metro Rail Line1-Phase BProjectand intends to apply a portion of the proceeds to engagea firm of international consultants (the consultant) to carry out planning of Line 2.
2. The main objective is to review and update the Detailed Project Report (DPR) for Jaipur Metro Rail Line 2 (North-South corridor of about 24 kilometers from Sitapura to Ambabari), including but not limited to assessingJaipur's urban transport sector, updating the traffic assessment, reviewing the preliminary engineering and system performance specification, updating cost estimate, conducting economic and financial assessment, and financial sustainability assessment in accordance with ADB guidelines, advising on implementation arrangement, optimized model for implementation, and preparing outline bidding documents.
3. It is estimated that the consulting services will require about 12 international person-months and 35 national person-months, implemented over 6 calendar months from the commencement date. The estimated cost is about USD 900,000, including provisional sum of USD 160,000 and contingency of USD 67,300. A detailed description of the requirements is provided in the outline terms of reference available on ADB website (<http://csrn.adb.org>) and JMRC website (<https://www.jaipurmetrorail.in/opentender.aspx>)
4. The Executing Agency is the Government of Rajasthan acting through Jaipur Metro Rail Corporation Ltd. (JMRC). The assignment location will be in Jaipur, India.Now eligible consulting firms are invited to indicate their interest in providing the required services. The EOI may be submitted online through ADB's website as follows:
