- 1. This is to inform you that your tender proposal has been accepted in respect to provide, own, operate & maintain 80 Nos. four wheeler CNG/Electric/Diesel operated Tata Magic type or equivalent vehicles as feeder services on all 9 Metro Stations of Phase-1A of JMRC at the license fee of Rs. 17,28,000/- (Rupees Seventeen Lac Twenty Eight Thousand only) for two years from the stipulated date of commencement.
- 2. The date of commencement of work shall be intimated through Orders to Commence and date of completion of the contract shall be twenty four months from the stipulated date of commencement. The stipulated date of commencement of work shall be within 10 days from the date of issue of Orders to Commence.
- 3. As per the terms & conditions of the tender, you are requested to return one copy of this LOA duly and unequivocally accepted, signed and stamped by your authorized signatory within 4 days from the date of issue of this LOA.
- 4. Prior to signing of the contract agreement, you shall submit the following documents within a period of 30 days from the date of issue of the Letter of Acceptance:
 - a) Performance Security of Rs. 86,400/- in the form of Bank Draft or Bankers Cheque or a Bank Guarantee of a scheduled bank based in India in favour of "Jaipur Metro Rail Corporation Ltd", Jaipur payable at Jaipur. The bank guarantee shall be valid for a period of 60 days beyond the date of completion of all contractual obligations, in Proforma provided in Form-D of the Tender document.

b) Police verification and valid driving license of each staff to be deployed.

c) Technical, Registration & Insurance detail of all vehicles to be deployed as per one, which has prototype approval of JMRC.
