2. Bids completed in all respects must be submitted at the address given in the NIB, not later than the time and date indicated therein. JMRC may, at its discretion, extend this deadline for the submission of Bids by amending the Bid Document and in that case, all rights and obligations of JMRC and the Bidders previously subject to the original deadline shall thereafter be subject to the deadline as extended.
3. Any Bid received after the deadline for submission of Bids will be liable to be rejected and returned unopened to the Bidder. No further correspondence on this subject shall be entertained by JMRC.
4. Bidders must submit their certificate of registration with Central/State Government and their undertakings.
5. Bid is to be submitted in prescribed form which can be obtained from the office on payment of Bid cost in cash or if it downloaded from the website then the Bid cost shall be submit through Banker's cheque/DD in favour of "Jaipur Metro Rail Corporation Ltd." payable at Jaipur at the time of submission of bid.
6. Bid submitted in response to the Bid Document shall be accompanied by a bid security (hereinafter referred to as "Bid Security" or "Earnest Money Deposit" or "EMD") of value as specified in NIB. Pay Order or Demand draft in favour of Jaipur Metro Rail Corporation Ltd. payable at Jaipur.
7. Any Bid not accompanied with valid Bid Security/ EMD and the cost towards downloaded Bid Form document, if any, in acceptable form will be liable to be treated as being non-responsive.
8. No interest will be payable on the Bid Security/EMD.
9. The Bid Security is liable to be forfeited, if the Bidder withdraws or amends or impairs or derogates from the Bid in any respect within the period of validity of its Bid or any extension thereof. The decision of JMRC in this respect shall be final and binding.
