Sub: Clarification/ modifications with regard to the queries raised by Agencies engaged in advertisement services during Pre-bid Conference on 02.02.2016.



Sl. No.	Clarification based on the discussion in pre-bid conference
1.	Clause 4.1 (xvii) - The agency will install iron standee of maximum 3 feet x 6 feet (WXH) size with proper self supporting stand and frame. The readymade roll off standees will not be allowed to be installed. However if the agency wants to change the size (either height or width) it can do so subject to prior approval of the JMRC. In such case, the maximum area of standees shall restrict to (18 square feet).
2.	Clause 4.1 (i) - As per RFP most of the locations will be available for standees in non paid area. However locations available in paid area will also be permitted on the request of the agency. In this case, agency will not be given any free passes for their workers for access to the location in the paid area. The agency will have to purchase smart cards from JMRC specially designed for such purpose. It is further clarified that the locations for deployment of standees are not available at Platform level due to security reason.
3.	Clause 4.6 (iii) – Licensee is liable to pay license fee of minimum 100 standees even if less number of standees are deployed. However on deployment of less number of standees due to reason attributed to JMRC, the licensee will be liable to pay license fee of actual number of standees.
4.	JMRC will not provide the free parking facility to the workers of the agency.
5.	Clause 4.4 – The agency will have to give their requirement for enhancement of number of standees to be deployed beyond minimum 100, fortnightly. JMRC will raise invoice on receipt of the requirement for additional quantity from the agency and will permit the deployment of required number of standees on advance payment of the amount of the raised invoice, if feasible.
