3. Any Bid received after the deadline for submission of Bids will be liable to be rejected and returned unopened to the Bidder. No further correspondence on this subject shall be entertained by JMRC.
4. Bid is to be submitted in prescribed form which can be obtained from the office on payment of Bid cost in cash or if it downloaded from the website then the Bid cost shall be submit through Banker's cheque/DD in favour of "Jaipur Metro Rail Corporation Ltd." payable at Jaipur at the time of submission of bid.
5. All pages of the Bid document must be signed by the agency/contractor.
6. Performance security shall be solicited from all successful bidders the amount of performance security shall be ten percent of the amount of work order.
 - Performance security shall be furnished in any one of the following forms-
 - (a) deposit though eGRAS;
 - (b) Bank Draft or Banker's Cheque of a scheduled bank;
 - (c) National Savings Certificates and any other script/instrument under National Savings Schemes for promotion of small savings issued by a Post Office in Rajasthan, if the same can be pledged under the relevant rules. They shall be accepted at their surrender value at the time of bid and formally transferred in the name of procuring entity with the approval of Head Post Master.
 - (d) Bank guarantee/s of a scheduled bank. It shall be got verified from the issuing bank. Other conditions regarding bank guarantee shall be same as mentioned in the RTPPR,2013;
 - (e) Fixed Deposit Receipt (FDR) of a scheduled bank, as per RTPPR,2013.
 - The contractor/bidder at the time of signing of the agreement, may submit option for deduction of performance security from his each running and final bill @10% of the amount of the bill, as per RTPPR,2013.
 - Performance security deposited by the contractor shall be refunded after completion of the work provided final bill have been paid.
