TERMS OF REFERENCE

Engaging Professional Traffic Consultant For Supervision, Coordination, Training and Liasoning with Traffic Police, for Smooth Traffic Movement and for implementing of approved traffic diversion plan During full road blockage at Badi Chaupar for ongoing Work of Phase-1B.

1. Introduction & Objective of assignment

- 1.1. Jaipur Metro Rail Corporation Ltd. (JMRC), hereinafter referred to **the "Corporation"**, is a Special Purpose Vehicle (SPV) formed by the State Government of Rajasthan, as a wholly owned State Enterprise for execution of the Jaipur Metro rail project.
- 1.2. The construction work of Jaipur Metro rail project phase-1B is under progress at Chhoti Chaupar and Badi Chaupar. Full road block has already been taken in tripoliya side of Badi Chaupar metro station and Traffic marshals are deployed at tripoliya side and it is required to trained them for smooth traffic movement and least inconvenience to road users.
- 1.3. Full traffic blockage at Badi Chaupar Ramganj side is expected to take from 01.07.2016 and alternate traffic route is used by road users till full road block remains in Ramganj side. To properly locate the signage boards and traffic diversion boards there is requirement of experience traffic personnel of minimum Sub Inspector level.
- 1.4. There is also need for monitoring, supervision, coordination and liasoning with traffic police, for proper management and implementing of approved so that the work of metro project may not affect the road users and there is no delay in assistance/approvals from the traffic police department.

2. Scope of Work

- 2.1. The Consultant will work under the officers of the level of General Manager & above in the corporation.
- 2.2. The scopes of the services in accordance with these Terms of References (ToR) include working in close co-ordination with the Corporation that will ensure smooth traffic movement and minimum inconvenience to road users, during execution of project work at Badi Chaupar.

Terms of Reference

3. Responsibility and Duties of the consultant

- 3.1 To monitor, supervise the proposed traffic blockage at Badi Chaupar so that there is smooth traffic movement and road users have least inconvenience during their movement.
- 3.2 To coordinate with local traffic police, and for implementing of approved traffic diversion plan during full road blockage at Badi Chaupar for ongoing Work of Phase-1B and give training to deployed Traffic Marshals for efficient traffic movement through proposed diverted traffic plan.

4 Qualifications of the Professional:

- 4.1 Professional must have experience of more than 20 year to work in the traffic department.
- 4.2 Professional must be 12th (Higher Secondary) from recognised Board.
- 4.3 Professional must have experience of consultation, supervision and liasoning the traffic works with other government departments under state government.

5 Commencement of Service:

The Professional shall commence their service with the date of issue of LOA (Letter of Acceptance).

6 Time Period of assignment

The Assignment shall be for the period of five months.

7 Financial Proposal

In preparing the Financial Proposal, the Professional is expected to take into account the requirements and conditions of the TOR. The Official shall take all costs associated with the Assignment, including remuneration and reimbursable other services as vehicle.

8 Payment Schedule

- 8.1 The remuneration of the Professional will be paid 22,000 INR monthly subject to maximum up to five months.
- 8.2 The reimbursement of mobile/telephone/internet expenses shall be up to Rs. 1200 per month.

- 8.3 The payment will be released to the Consultant after due verification of reporting officer on the basis of monthly attendance.
- 8.4 The duty hours of the Professional are from 09.30 AM to 06.00 PM. The Professional is entitled for all the Govt. Holidays; however Professional may be called after duty hours or on any Holidays as per the requirement and no extra payment will be made for it.
- 8.5 The Professional is entitled for 5 days casual leave and if he avail leave more than 5 days then payment will be deducted on prorata basis.

9 Conflict of Interest

The Corporation requires that the Professional provides professional objective, and impartial advice and at all times hold the Corporation's interests paramount, avoid conflicts with other assignments or its own corporate interests, and act without any consideration for future work. The Professional shall not engage, either directly or indirectly, during the term of this Agreement, any business or professional activities which would conflict with the activities assigned to them under this Agreement.

10 Termination of Assignment:

An Agreement shall be executed between the Professional and Corporation. The agreement between the Professional and the Corporation can be terminated by the Corporation by giving a written notice of not less than one month, if the Professional fails to perform its part of the duties and responsibilities substantially. The Corporation after having terminated the contract shall have the right to deploy another Official.
