The quotation is to be submitted in the prescribed format as per Annexure under following terms & conditions:

- 1. The various maintenance work and supply and installation of spare parts of air conditioners (including spares and consumables) of Window/wall Split/Cassette Split Air Conditioners including full overhauling/servicing cleaning, replacement of spare parts/defective components installed in JMRC offices.
- 2. The company will request for any replacement after inspection of the defaulted AC, any such replacement of the parts will be carried out after issue of work order for the same.
- 3. The rates to be quoted in Annexure-A for repair & maintenance and Spare parts are inclusive of all Taxes except GST.
- 4. Time for corrective maintenance is 03 days from the date of reporting any issue in AC units.
- 5. Contractor should have GST registration number.
- 6. Old parts supplied and installed will be the property of JMRC.
- 7. This rate contract is for one year, and extendable further up to 03 months on mutual consent.
- 8. Payment shall be made on submission of bills on completion of the work under the supervision of JMRC official.
- 9. Variation of the quantity of works will be governed as per RTPPR, 2013.
