



2.4 Language of Bidding

The Bid, as well as all correspondence and documents relating to the Bid exchanged by the service provider and the procuring entity, shall be written only in English/ Hindi Language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in English/ Hindi language, in which case, for purposes of interpretation of the Bid, such translation shall govern.

2.5 Negotiations

- d) Negotiations may, however, be undertaken with the Service provider when the rates of any job type are considered to be much higher than the prevailing market rates or the rates quoted for that job type by other service providers.
- e) The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.
- f) A minimum time of seven days shall be given for calling negotiations. - a. If the supplier/ Contractor fails to deliver any or all quantities of the service within the time period specified in the contract, or any extension thereof granted by JMRC; or


2.8 Performance Security:

- 2.8.1 Prior to execution of Contract Agreement, Performance security shall be solicited from the successful Bidder as per format attached as Form 'A'.
- The amount of performance security shall be 10% of the contract amount.
- Performance security shall be furnished in any one of the following forms: -2.8.3
 - Bank Draft or Banker's Cheque of a scheduled Commercial bank;
 - b. Bank guarantee/s of a scheduled Commercial bank. It shall be got verified from the issuing bank.
- Performance security above shall remain valid for a minimum period of 41 months from issuance of LOA and must include all contractual obligations of the Bidder, including warranty/guarantee/Defect liability period obligations, if any.

Both servers are EOL/EOS products which are to be changed with new one latest as well as compatible version. After installation and configuration of both new servers with existing system, multicasting redressal is to be done to enable the live view of all camera installed in Jaipur Metro on Video wall.

Multicasting redressal herein means with the availability of view for all the cameras installed at Jaipur Metro at the said installed Video Wall continuously without any fluctuation, hang, flickering etc.



- Service provider shall only be liable or responsible for any damages during transportation of the new items till installation.
- Multicasting redressal shall be done within 45 days from the date of issuing of LOA. The new items will be installed with submission of the following reports:-

4.2 Comprehensive Annual Maintenance:-

Comprehensive Annual Maintenance of Video wall system installed at Security Control Room, Mansarovar Metro Depot in JMRC will include services, repairs and replacements (if necessary) to upkeep the Video wall system of Jaipur Metro in good working condition and shall include following scope of work as minimum:-

- a) Preventive Maintenance: The preventive maintenance shall be done on Half yearly basis. His scope of work includes working of whole video wall unit check-up, general cleaning, Technical update, repair/replacement of components, Color Matching & Geometry Adjustment and the activities listed down at para 4.2.3 as a minimum. It shall also cover the maintenance activity as per the standard Barco checklist and agreed by JMRC. The final preventive check list is to be get approved by JMRC prior to start of CAMC.
- During preventive maintenance, engineer shall record the observations in the log book/service report with his signature in addition to day to day attending of faults/Maintenance when reported by JMRC staff. The contractor will submit the preventive maintenance service report after performing the same and should be endorsed by JMRC staff.

b) Corrective/Breakdown Maintenance:

Breakdown/Corrective maintenance calls as & when required in event of failure of the Offered maintenance Contract services are Comprehensive in nature, which will ensure improvement in following area:

- Proactive Service
- High uptime
- Quality Service by OEM
- System Functionality
- Protection from inflation under longer contract.
- Predictive cost

The Service plan for executing the work for corrective maintenance shall include the following procedures:-

- In case of any failure/fault, a complaint will be logged through call/e-mail for which a complaint ticket No. will be issued. The ticket number will be tracking reference for both parties till the closure of failure/fault.
- In first step, the failure may be attended by providing telephonic/on call support to JMRC staff. If failure rectified by telephonic/on call support then the complaint ticket will be closed automatically.
- The response time for Breakdown/corrective maintenance call –Telephonic support/remote support shall be within 4 business hours i.e. between 9am to 6pm Monday to Sunday.
- But if the failure could not be rectified on telephonically, then the visit of contractor's engineer is necessitated within next business day (Intervention time between 9am-6pm Monday to Sunday).

The contractor will attend to all the calls from JMRC on all working days. The urgent, immediate and unavoidable calls are also to be attended before and after the usual office time and even on holidays. However, the reasonable time would be allowed for the specific jobs on the merits of the jobs. JMRC reserves the rights to decide any job as urgent or unavoidable depending upon the nature and venue of the job. The Service provider is liable to take the maintenance job in the holidays due to urgency of work/ instruction of the In-Charge, Telecom of this Office.

The contractor shall provide helpline number with a list of maintenance staff/engineer together with the contact mobile/ telephone number who can be contacted for support in case of emergency.

If any part of the system found faulty during failure then the faulty part/item shall be replaced by the service provider from its own spares. Service provider shall have to maintain his own spare including following consumables items i.e. Lamp and Dust filter) however other consumables like Screen, Mirror, Cables, Structure, Dimmer, keyboard, Mouse will be maintained by JMRC for CAMC.

For any malfunctioning/ failure of any hardware device, part/ component, contractor will replace/ rectify the part/ parts with the same/ similar part number or the latest parts available from the original manufacturer along with the warranty details of the replaced item/part.

The spare part for replacement shall be received within 03 day from the response time.

The maximum time to restore the failure 05 days in case of spare part replacement otherwise 02 days.

It's the responsibility of BESL to arrange the device drivers of the items of any used under different operating systems.

In case of intermittent failures and repetitive problems due to improper diagnosis or repair, the items will be treated as continuously down.

The equipment will be handed over back to JMRC after the AMC period in good working condition.

General Terms and conditions

Response time, MTTR and penalty will be same as per clause 4.2.1 & 4.2.2 for both preventive and corrective maintenance.

The contractor should depute only qualified / experienced technicians for carrying out the preventive and corrective maintenance work.

Other than regularly preventive maintenance, the contractor's Engineer shall also be engaged during preventive maintenance scheduled by JMRC's staff in case of assistance required by JMRC. Any abnormality of the system found during preventive maintenance shall also be considered a part of Comprehensive AMC and same shall be reported to contactor through telephonically, sms or e-mail and contractor shall attend the call and carryout corrective maintenance / rectification. Contractor shall make his all out efforts to adhere the time schedule of preventive as well as corrective maintenance.

5. GRIEVANCE REDRESSAL DURING PROCUREMENT PROCESS

The designation and address of the First Appellate Authority is Director (O& S), JAIPUR METRO RAIL CORPORATION, JAIPUR.

The designation and address of the Second Appellate Authority is MD, JAIPUR METRO RAIL CORPORATION, JAIPUR.

(1) Filing an appeal

If the Service provider is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Service provider as successful the appeal may be filed only by a Service provider who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Service provider whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under Para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it within thirty days from the date of the appeal.
- (3) If the officer designated under Para (1) fails to dispose of the appeal filed within the period specified in Para (2), or if the Service provider or prospective service provider or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Service provider or prospective service provider or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in Para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

(4) Appeal not to be in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

(a) determination of need of procurement;

(b) provisions limiting participation of Service providers in the Bid process;

- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.
- (4) Form of Appeal
- (a) An appeal under para (I) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(5) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

(6) Procedure for disposal of appeal

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall,-
 - (i) Hear all the parties to appeal present before him; and
 - (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal.
