In reference to above it is informed to all concerned that M/s SUKANKSHA CONSTRUCTIONS; Address: Gayatri Bunglow No-06 & 07, Near Guruprerna Apartment, Aptewadi, Shrigaon, Badlapur (E), District-Thane-421503. E-Mail:sushilagarwal1962@gmail.com was awarded the said work of "Repair and Maintenance Work of P.Way as required in Metro Line of JMRC from Mansarover to Chandpole Metro Station including of Mansarovar Depot" through Online Bidding Process through E-Proc website of Rajasthan Government.

The bidder was neither turned up for the start of work nor for the signing of agreement with JMRC for the said work even after repeated reminders of JMRC. Hence the bid security as referred under (e) was forfeited by JMRC as per RTPPR-2013. Further as the bidder has spoiled the time of JMRC in the bidding process and shown non-responsiveness against the communications of JMRC for the said work, hence as per Clause 46(4) of RTPPA-2012; M/s Sukanksha Constructions is hereby debarred from the participation in any bidding processes of JMRC for the period of 03 Years from the date of issue of this order. The consideration of bidder by any organization shall be at their own risk.
