#### 2 INSTRUCTION TO BIDDERS

# 2.1 Sale of Bidding/ Bid Documents

The sale of bidding documents shall be commenced from the date of publication of Notice Inviting Bids (NIB). The complete bidding documents are placed on the State Public Procurement Portal and JMRC website as per NIB. The prospective Bidders shall download the bidding document from the specified website(s) and pay its bid cost on or before while submitting the bid to the procuring entity.

The bidding documents shall be made available to any prospective Bidders who pays the Bid cost for it in demand draft/banker's cheque.

Note: Bid documents cost is not refundable in any case.

#### 2.2 Cost of bid document and Bid Security/EMD

The Bid should be submitted in the prescribed Bid document, which may be purchased for Rs.590/- includes 18 % GST, by submitting DD/Banker Cheque as per NIB. The complete bid document can be downloaded from the website <a href="http://transport.rajasthan.gov.in/jmrc">http://transport.rajasthan.gov.in/jmrc</a> or <a href="www.sppp.rajasthan.gov.in">www.sppp.rajasthan.gov.in</a>. In case the bid document is down loaded from website, the cost of bid document is to be submitted in the form of DD/Banker's Cheque along with the Bid document submitted. In no case the cost of bid form is refundable.

EMD/Bid Security can be deposited as per NIB and shall form part of the bid.

- 2.2.1 EMD/Bid security shall be 2% of the estimated value of subject matter of procurement put to bid. In case of Small Scale Industries of Rajasthan it shall be 0.5% of the quantity offered for supply and in case of sick in industries other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the value of bid. In lieu of bid security, a bid securing declaration shall be taken from Departments of the State Government and Undertakings, Corporations, Autonomous bodies, Registered Societies, Cooperative Societies which are owned or controlled or managed by the State Government and Government Undertakings of the Central Government. (Please refer rule 42 of RTPPR i.e. Rajasthan Transparency in Public Procurement Rules, 2013)
- 2.2.2 The EMD/ Bid Security of successful Bidder shall be adjusted against Performance Security Deposit or discharged/ returned after deposition of the Performance Security Deposit, as the case may be.
- 2.2.3 The Bid Security taken from a bidder shall be forfeited, if any, in the following cases, namely:
  - a. when the bidder withdraws or modifies its bid after opening of bids;
  - b. when the Bidder fails to commence the supply of the goods or service or execute work as per supply/ work order within the time specified;
  - c. when the Bidder does not deposit the performance security within specified period after the supply/ work order is placed; and

- d. If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the bidding document.
- 2.2.4 Notice will be given to the Bidder with reasonable time before Bid Security (EMD) deposited is forfeited.
  - 2.2.5 No interest shall be payable on the Bid Security (EMD).
- 2.2.6 In case of the successful Bidder, the amount of Bid Security may be adjusted in the amount of Performance Security, or refunded, if the successful Bidder furnishes the full amount of performance security.
- 2.2.7 The procuring entity shall promptly return the Bid Security if not adjusted in performance security of the successful Bidder after the earliest of the following events, namely:
  - a. the expiry of validity of Bid Security;
  - b. Issue of LOA for procurement and performance security is furnished by the successful Bidder:
  - c. the cancellation of the procurement process; or
  - d. The withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.
- 2.2.8 The Bid Security of the Bidders who's Bids could not be accepted shall be refunded soon after the contract with the successful Bidder is signed and its performance security is obtained.

# 2.3 Changes in the Bidding Document

At any time, prior to the deadline for submission of Bids, the procuring entity may for any reason, whether on its own initiative or as a result of a request for clarification by a Bidder, modify the bidding documents by issuing an addendum in accordance with the provisions below.

In case, any modification is made to the bidding document or any clarification is issued which materially affects the terms contained in the bidding document, the procuring entity shall publish such modification or clarification in the same manner as the publication of the initial bidding document.

In case, a clarification or modification is issued to the bidding document, the procuring entity may, prior to the last date for submission of Bids, extend such time limit in order to allow the bidders sufficient time to take into account the clarification or modification, as the case may be, while submitting their Bids.

# 2.4 Period of Validity of Bids

Bids submitted by the Bidders shall remain valid during the period specified in the NIB/bidding document. A Bid valid for a shorter period may be rejected by the procuring entity as non-responsive Bid.

Prior to the expiry of the period of validity of Bids, the procuring entity, in exceptional circumstances, may request the Bidders to extend the bid validity period for an additional

specified period of time. A Bidder may refuse the request and such refusal shall be treated as withdrawal of Bid and in such circumstances Bid Security shall not be forfeited.

# 2.5 Format and Signing of Bids

The Bidder shall prepare one original set of the bidding documents called Bid in the manner as specified in the bidding document.

All pages of the bid shall be signed by the Bidder or a person duly authorized to sign on behalf of the Bidder, in token of acceptance of all the terms and conditions of the bidding documents. This authorization shall consist of a written confirmation as per Form C.

Any corrections in the bid such as interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the bid.

# 2.6 Sealing and Marking of Bids

- 2.7.1 Single envelope shall comprise of the following:
  - a. Name and complete address along with telephone/ mobile number of the Bidder;
  - b. Complete address of the procuring entity with telephone number, if any;
  - c. The specific identification of the bidding process pursuant to NIB and any additional identification marks as specified in the bidding document; and
- 2.7.2 A single-stage single envelope selection method shall be adopted.

The complete bid document will be consisting of following:-

- a. Bid Cost/Proof of Bid cost (if already submitted)
- b. Bid security.
- c. Bid Document The bidder shall enclose duly signed and stamped, copy of the Bid Document along with BOQ (Form H). Bids signed without any of the information desired in the prescribed formats will not be considered. Besides this all other associated / required documents shall be submitted duly numbered and signed/ stamped by the bidders.

# 2.7 Cost & Language of Bidding

- 2.7.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the procuring entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- 2.7.2 The Bid, as well as all correspondence and documents relating to the Bid exchanged by the bidders and the procuring entity, shall be written only in English/ Hindi Language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in English/ Hindi language, in which case, for purposes of interpretation of the Bid, such translation shall govern.

# 2.8 Alternative/ Multiple Bids

Alternative/ Multiple Bids shall not be considered at all.

# 2.9 **Deadline for the submission of Bids**

Bids shall be received, by the person, designated for the purpose, by the procuring entity or directly dropped in the bid box, at the place and up to the time and date specified in the NIB.

#### 2.10 Late Bids

- 2.10.1 The person authorized to receive the bids shall not receive any bid that is submitted personally, after the time and date fixed for submission of bids.
- 2.10.2 Any bid, which arrives by post after the deadline for submission of bids, shall be declared and marked as "Late" and returned unopened to the Bidder.

# 2.11 Receipt and Custody of Bids

2.11.1 The bids must be enclosed in a sealed cover, superscripted "Bid No.\_\_\_\_\_" and shall be received by hand delivery, by courier or by post in the specified format up to the specified time and date and at specified place, by the person authorized by the procuring entity.

- 2.11.2 The person authorised to receive the bids shall provide a receipt signed by him with date and time of receipt of bid to the person, who delivers the bid.
- 2.11.3 All bids received unsealed, in torn or damaged condition through post or by personal delivery shall be so marked and signed on the cover by the person receiving the same and get signed on it by the person delivering it and put in a fresh cover and reseal, if so warranted. All such entries shall be attested by the receiving person.
- 2.11.4 The received bids shall be kept in safe custody in lock and key by the person authorized to receive the bids.
- 2.11.5 The location of bid box shall be such as to facilitate easy access to Bidders.
- 2.11.6 Bids received by the authorized person on or before the time and date fixed for receipt of bids shall be entered in bids receipt register and the same shall be closed at the scheduled time and date giving in words and figures the number of bids received up to the last time and date for submission of bids.
- 2.11.7 The record of bids received late through post shall be entered in bids receipt register after closing the register as per above.
- 2.11.8 Bids received by telegram or given on form other than the prescribed form shall not be considered.

# 2.12 Withdrawal, Substitution, and Modification of Bids

- 2.12.1 A Bidder may withdraw, substitute, or modify its bid after it has been submitted by sending a written Notice, duly signed by an authorized signatory, and shall include a copy of the authorization. The corresponding substitution or modification of the bid must accompany the respective written Notice. All Notices must be:
  - a. Submitted in accordance with the bidding document, and in addition, the respective envelopes shall be clearly marked "Withdrawal," "Substitution," "Modification"; and
  - b. Received by the procuring entity prior to the deadline prescribed for submission of bids.
- 2.12.2 Bids requested to be withdrawn shall be returned unopened to the Bidders.
- 2.12.3 No bid shall be withdrawn, substituted, or modified after the last time and date fixed for receipt of bid.

# 2.13 **Opening of Bids**

- 2.13.1 The sealed bid box shall be opened by the bid opening committee constituted by the procuring entity at the time, date and place specified in the bidding document in the presence of the Bidders or their authorised representatives, who choose to be present.
- 2.13.2 The bids receiving person shall also hand over all the bids received by him up to the time and date for submission of bids to the Convener of bids opening committee and obtain its signature in the bids receipt register.

- 2.13.3 The bid opening committee may co-opt experienced persons in the committee to conduct the process of bid opening.
- 2.13.4 The bids shall be opened by the bids opening committee in the presence of the Bidders or their authorized representatives who choose to be present. All envelopes containing bids shall be signed with date by the members of the committee in token of verification of the fact that they are sealed. The envelopes shall be numbered as a/n, where 'a' denotes the serial number at which the bid envelop has been taken for opening and 'n' denotes the total number of bids received by specified time.
  - 2.13.5 The bid opening committee shall prepare a list of the Bidders or their representatives attending the opening of bids and obtain their signatures on the same. The list shall also contain the representative's name and telephone number and corresponding Bidders' names and addresses. The authority letters brought by the representatives shall be attached to the list. The list shall be signed by all the members of bid opening committee with date and time of opening of the bids.
  - 2.13.6 Envelopes shall be opened one at a time and the following details shall be read out and recorded:
    - a. The name of the Bidder and whether there is a substitution or modification;
    - b. The bid prices (per lot if applicable);
    - c. The Bid Security, if required; and
    - d. Any other details as the committee may consider appropriate.
  - 2.13.7 After all the bids have been opened, they shall be initialled and dated on the first page of the each bid by the members of the bids opening committee. All the pages of the price schedule and letters, Bills of Quantities attached shall be initialled and dated by the members of the committed. Key information such as prices, delivery period, etc. shall be encircled and unfilled spaces in the bids shall be marked and signed with date by the members of the committee. The original and additional copies of the bid shall be marked accordingly. Alterations/ Corrections/ Additions/ over writings shall be initialled legibly to make it clear that such alteration, etc, were existing in the bid at the time of opening.
- 2.13.8 No bid shall be rejected at the time of bid opening except the late bids, alternative bids (if not permitted) and bids not accompanied with the proof of payment or instrument of the required price of bidding document, processing fee (if any) or user charges and Bid Security.

#### 2.14 Selection Method

The selection method is Least Cost Based Selection (LCBS) as detailed below:

2.14.1 Single bid system, bid will be opened on scheduled time and date as per NIB. The contract will be award to technically compatible & most advantageous bidder of financial bid.

- 2.14.2 The ranking of L1, L2, L3 etc, will be done on basis of Total Cost, with L1 being the Bidder whose Total Cost is the lowest, L2 being the second lowest and so on.
- 2.14.3 In case two or more responsive bidders have quoted the same Cost, which is also the lowest amount offered, then JMRC will resort to an open auction among the same bidders(i.e. who have quoted the same Total cost) and the bidder for respective bid whose offer is lowest, shall be declared as successful bidder. The date and time of auction will be notified to the concerned bidders.

#### 2.15 Clarification of Bids

- 2.15.1 To assist in the examination, evaluation, comparison and qualification of the Bids, the bid evaluation committee may, at its discretion, ask any Bidder for a clarification regarding its Bid. The committee's request for clarification and the response of the Bidder shall be in writing.
- 2.15.2 Any clarification submitted by a Bidder with regard to its Bid that is not in response to a request by the committee shall not be considered.
- 2.15.3 No change in the prices or substance of the Bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by the committee in the evaluation of the financial Bids.
- 2.15.4 No substantive change to qualification information or to a submission, including changes aimed at making an unqualified Bidder, qualified or an unresponsive submission, responsive shall be sought, offered or permitted.
- 2.15.5 All communications generated under this rule shall be included in the record of the procurement proceedings.

#### 2.16 Evaluation & Tabulation of Bids

#### 2.16.1 **Preliminary Examination of Bids**

- 2.16.1.1 The bid evaluation committee constituted by the procuring entity shall conduct a preliminary scrutiny of the opened bids to assess the prima-facie responsiveness and ensure that the:
  - a. Bid is signed, as per the requirements listed in the bidding document;
  - b. Bid has been sealed as per instructions provided in the bidding document;
  - c. Bid is valid for the period, specified in the bidding document;
  - d. Bid is accompanied by bidding document fee, Bid Security.
  - e. Bid is unconditional and the Bidder has agreed to give the required performance security; and
  - f. Other conditions, as specified in the bidding document are fulfilled.
  - g. Bid not accompanied by Bid cost, Bid security /EMD & Form I will be considered as non-responsive & will not be considered for evaluation.

#### 2.16.1.2 **Determination of Responsiveness**

- ➤ The bid evaluation committee shall determine the responsiveness of a Bid on the basis of bidding document and the provisions of pre-qualification/eligibility criteria of the bidding document.
- A responsive Bid is one that meets the requirements of the bidding document without any material deviation, reservation, or omission where:
  - a. "Deviation" is a departure from the requirements specified in the bidding document:
  - b. "Reservation" is the setting of limiting conditions or withholding from complete acceptance of the requirements specified in the bidding document; and
  - c. "Omission" is the failure to submit part or all of the information or documentation required in the bidding document.
- A material deviation, reservation, or omission is one that,
  - i. If accepted, shall:-
    - 1. Affect in any substantial way the scope, quality, or performance of the subject matter of procurement specified in the bidding documents;

OR

2. Limits in any substantial way, inconsistent with the bidding documents, the procuring entity's rights or the Bidder's obligations under the proposed contract;

OR

- 3. If rectified, shall unfairly affect the competitive position of other Bidders presenting responsive Bids.
- ➤ The bid evaluation committee shall examine the technical aspects of the Bid in particular, to confirm that all requirements of bidding document have been met without any material deviation, reservation or omission.
- The procuring entity shall regard a Bid as responsive if it conforms to all requirements set out in the bidding document, or it contains minor deviations that do not materially alter or depart from the characteristics, terms, conditions and other requirements set out in the bidding document, or if it contains errors or oversights that can be corrected without touching on the substance of the Bid.

#### 2.16.1.3 Non-material Non-conformities in Bids

- ➤ The bid evaluation committee may waive any non-conformity in the Bid that does not constitute a material deviation, reservation or omission, the Bid shall be deemed to be substantially responsive.
- ➤ The bid evaluation committee may request the Bidder to submit the necessary information or document like GST certificate, Pan certificate, etc. within a reasonable period of time. Failure of the Bidder to comply with the request may result in the rejection of its Bid.

- ➤ The bid evaluation committee may rectify non-material nonconformities or omissions on the basis of the information or documentation received from the Bidder under above.
- ➤ Bids shall be evaluated based on the documents submitted as a part of bid. Bidders are expected to quote for all the items. Similarly, in case the proposal of a Bidder is non-responsive for any item, the Bidder shall be summarily rejected.
- The evaluation shall include all costs and all taxes and duties applicable to the Bidder as per law of the Central/ State Government/ Local Authorities, and the evaluation criteria specified in the bidding documents shall only be applied;
- ➤ The offers shall be evaluated and marked L1, L2, L3 etc. L1 being the lowest offer quoting least value of 'Total Cost in financial bid. A list of L1, L2....will be prepared accordingly.
- The rates quoted by L1 Bidder shall be accepted as the Bid rates.
- In case of exceptional high rate for any item/sub activity, negotiation shall be held with L1 firm on the quoted rate of respective item/sub activity. In case of failure of negotiation, rate contract for that particular item shall not be entered into.
- The members of bid evaluation committee shall give their recommendations below the table regarding lowest bid or most advantageous bid and sign it.

#### 2.17 Correction of Arithmetic Errors in Financial Bids:

- 2.17.1 The bid evaluation committee shall correct arithmetical errors in substantially responsive Bids, on the following basis, namely: -
  - 2.17.1.1 If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the bid evaluation committee there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
  - 2.17.1.2 If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to clause (2.18.1.1) and above.

#### 2.18 Negotiations

2.18.1 Negotiations may, however, be undertaken with the lowest Bidder when the rates of any job type are considered to be much higher than the prevailing market rates or the rates quoted for that job type by other bidders.

- 2.18.2 The bid evaluation committee shall have full powers to undertake negotiations. Detailed reasons and results of negotiations shall be recorded in the proceedings.
  - 2.18.3 The lowest Bidder shall be informed in writing either through registered letter and email (if available). He will be called for negotiation if required.
- 2.18.4 Negotiations shall not make the original offer made by the Bidder inoperative. The bid evaluation committee shall have option to consider the original offer in case the Bidder decides to increase rates originally quoted or imposes any new terms or conditions.
  - 2.18.5 In case of non-satisfactory achievement of rates from lowest Bidder, the bid evaluation committee may choose to make a written counter offer to the lowest Bidder and if this is not accepted by him, the committee may decide to reject and reinvite Bids or to make the same counter-offer first to the second lowest or most advantageous Bidder, then to the third lowest or most advantageous Bidder and so on in the order of their initial standing and work/ supply order be awarded to the Bidder who accepts the counter-offer. This procedure would be used in exceptional cases only.
  - 2.18.6 In case the rates even after the negotiations are considered very high, fresh Bids shall be invited.

## 2.19 Acceptance of the successful Bid and Issuance of Purchase Order

- 2.19.1 The procuring entity after considering the recommendations of the bid evaluation committee and the conditions of Bid, if any, financial implications, trials, sample testing and test reports, etc., shall accept or reject the successful Bid. If any member of the bid evaluation committee has disagreed or given its note of dissent, the matter shall be referred to the next higher authority, as per delegation of financial powers, for decision.
- 2.19.2 Decision on Bids shall be taken within original validity period of Bids and time period allowed to procuring entity for taking decision. If the decision is not taken within the original validity period OR time limit allowed for taking decision, the matter shall be referred to the next higher authority in delegation of financial powers for decision.
- 2.19.3 Before issuance of purchase order the procuring entity shall ensure that the price of successful Bid is reasonable and consistent with the required quality.
- 2.19.4 A Bid shall be treated as successful only after the competent authority has approved the procurement in terms of that Bid.
- 2.19.5 The Bid Security of the Bidders who's Bids could not be accepted shall be refunded soon after the contract with the successful Bidder is signed and its performance security is obtained.

- 2.19.6 Prior to the expiry of the period of validity of the bid, the successful bidder shall be notified through a Letter of Acceptance (LoA) sent through email to be confirmed in writing by Registered / Speed Post / By hand that its Bid has been accepted.
- 2.19.7 Upon receipt of the 'LOA', the successful bidder(s) shall return one copy of the LOA duly signed and accepted and stamped by its authorized signatory within 7 working days from the date of issue of LOA and submit the Performance Security Deposit within 15 days from the date of issue of LOA.
- 2.19.8 If the bidder fails to deposit the required Performance Security Deposit within the specified period without any intimation to JMRC, such failure will be treated as a breach of the terms and conditions of the tender and may result in forfeiture of the Earnest Money Deposit (Bid Security) in part, or in full at the discretion of JMRC. Any request for extension of time for deposition of Performance Security Deposit shall be made in writing with due justification and it shall be at the discretion of JMRC to accept or reject such request.
- 2.19.9 In case of non-acceptance of LOA by the successful bidder, JMRC shall cancel the LOA and may award the contract to the bidder next in the ranking, at its discretion.

# 2.20 Procuring entity's right to accept or reject any or all Bids

2.21.1 The Procuring entity reserves the right to accept or reject any Bid, and to annul (cancel) the bidding process and reject all Bids at any time prior to award of contract, without thereby incurring any liability to the Bidders as per RTPP Act and Rules.

# 2.21 Right to Vary Quantity

- 2.21.1 If the procuring entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding documents due to change in circumstances, the Bidder shall not be entitled for any claim or compensation.
- 2.21.2 Variation in quantity applicable is as per RTPPR RULE.
- 2.21.3 Orders for extra items or additional quantities may be placed on the rates and conditions given in the contract. Delivery or completion period may also be proportionately increased.

# 2.22 Performance Security Deposit

2.22.1 Prior to execution of work order, Performance security shall be solicited from successful Bidder except the departments of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them. The State Government may relax the provision of performance security in particular procurement or any class of procurement.

- 2.22.2 The amount of performance security shall be 5% of the amount of supply order in case of procurement of goods and services.
- 2.22.3 Performance security shall be furnished in any one of the following forms:
  - a. Bank Draft or Banker's Cheque of a scheduled bank;
  - b. Bank guarantee/s of a scheduled bank. It shall be got verified from the issuing bank. Other conditions regarding bank guarantee shall be same as mentioned in the bidding document for Bid Security.
  - c. Fixed Deposit Receipt (FDR) of a scheduled bank. It shall be in the name of procuring entity on account of Bidder and discharged by the Bidder in advance. The procuring entity shall ensure before accepting the FDR that the Bidder furnishes an undertaking from the bank to make payment/ premature payment of the FDR on demand to the procuring entity without requirement of consent of the Bidder concerned. In the event of forfeiture of the performance security, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit.
- 2.22.4 Performance security furnished in the form specified in clause 2.22.3 [b] to [c] above shall remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the Bidder, including warranty obligations.
- 2.22.5 Forfeiture of Performance Security: Security amount in full or part may be forfeited, including interest, if any, in the following cases:
  - a. When any terms and condition of the contract is breached.
  - b. When the Bidder fails to make complete supply satisfactorily.
  - c. If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the bidding document.
- d. If bidder fails to achieve compatibility of the supplied KVMs under this bid with existing system in JMRC as per Form I.
  - 2.22.6 Notice will be given to the Bidder with reasonable time before Performance Security deposited is forfeited.
  - 2.22.7 No interest shall be payable on the Performance Security Deposit.

#### **3** General Conditions of Contract

#### 3.1 Terms & Conditions

#### 3.1.1 Contract Documents:

Subject to the order of precedence set forth in this bid document, all documents forming the Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory.

#### 3.1.2 Scope of Supply

Subject to the provisions in the bidding document and contract, the goods and related services to be supplied shall be as specified in the purchase order.

#### **3.1.3 Delivery**

- 3.1.3.1 Subject to the conditions of the contract, the goods should be delivered within 08 weeks from the Date of P.O /LOA or earlier.
- 3.1.3.2 The above material shall be delivered at AFC/Tele Store, Room No. 316, IIIrd floor, Admin building, Mansarovar Metro train Depot, Bhrigu path, Mansarovar, Jaipur-302020.

# 3.1.4 **Specifications and Standards**

- 3.1.4.1 Technical Specifications and Drawings
  - a. The Supplier/ Contractor shall ensure that the goods and related services comply with the technical specifications and other provisions of the Contract.
  - b. The Supplier/ Contractor shall be entitled to disclaim responsibility for any design, data, drawing, specification or other document, or any modification thereof provided or designed by or on behalf of the Purchaser, by giving a notice of such disclaimer to the Purchaser.
  - c. The goods and related services supplied under the Contract for execution of work order shall conform to the standards mentioned in work order and, when no applicable standard is mentioned, the standard shall be equivalent or superior to the official standards whose application is appropriate to the country of origin of the Goods.
- 3.1.4.2 Wherever references are made in the Contract to codes and standards in accordance with which it shall be executed, the edition or the revised version of such codes and standards shall be those specified in the work order. During Contract execution, any changes in any such codes and standards shall be applied only after approval by the Purchaser and shall be treated in accordance with the general conditions of the contract.

# 3.1.5 **Inspection**

3.1.5.1 The Purchase Officer or his duly authorized representative shall inspect the item delivered for its compatibility & workability with the existing system and will issue acceptance letter accordingly.

# 3.1.6 **Rejection**

- 3.1.6.1 Articles not approved during inspection or testing shall be rejected and will have to be replaced by the Contractor at his own cost within the time fixed by the Purchase Officer.
- 3.1.6.2 If, however, due to exigencies of work, such replacement either in whole or in part, is not considered feasible, the Purchase Officer after giving an opportunity to the Contractor of being heard shall for reasons to be recorded, deduct a suitable amount from the approved rates. The deduction so made shall be final.
- 3.1.6.3 The rejected articles shall be removed by the supplier/ Bidder/ Contractor within 15 days of intimation of rejection, after which Purchase Officer shall not be responsible for

any loss, shortage or damage and shall have the right to dispose of such articles as he thinks fit, at the Contractor's risk and on his account.

# 3.1.7 **Liquidated Damages (LD)**

- 3.1.7.1 Contractor/supplier shall supply the material within stipulated delivery period as per clause 3.1.3. In case of delay beyond his control he shall seek extension well within the delivery period from competent authority i.e. Procuring Entity (P.E.). Procuring Entity (P.E.) shall communicate his decision which shall be binding on the contractor /supplier. Extension may be given with/without liquidity damages In case extension is given with liquidity damages, rates in this case shall be as under:.
  - **a.** Delay from the original delivery last date /extended last date without LD to first one week: Rs. 1000/- per day
  - **b.** From the end of first week to one week: Rs. 1500/- per day
  - c. From the end of 2 weeks to further 2 week: Rs. 2000/- per day
- 3.1.7.2 Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day.
- 3.1.7.3 The maximum amount of liquidated damages shall be 10% of the contract value.
- 3.1.7.4 If the supplier requires an extension of time in completion of contractual supply on account of occurrence of any hindrance, he shall apply in writing to the authority, which has placed the supply order, for the same immediately on occurrence of the hindrance but not after the stipulated date of completion of supply.
- 3.1.7.5 Delivery period may be extended with or without liquidated damages if the delay in the supply of goods is on account of hindrances beyond the control of the Bidder.

#### 3.1.8 **Termination**

- 3.1.8.1 Termination for Default
- 3.1.8.2 The Bid sanctioning authority of JMRC may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least 30 days sent to the supplier/ Contractor, terminate the contract in whole or in part:
  - a. If the supplier/ Contractor fails to deliver any or all quantities of the service within the time period specified in the contract, or any extension thereof granted by JMRC;

b. If the supplier/ Contractor fails to perform any other obligation under the contract within the specified period of delivery of service or any extension granted thereof;

c. If the supplier/ Contractor, in the judgment of the Purchaser, is found to be engaged in corrupt, fraudulent, collusive, or coercive practices in competing for or in executing the contract.

OR

d. If the supplier/ Contractor commits breach of any condition of the contract.

3.1.8.3 If JMRC terminates the contract in whole or in part, amount of Performance Security Deposit may be forfeited.

#### **3.1.9 Notices**

- 3.1.9.1 Any notice, invoice or other communication required or permitted under this contract shall be given in writing/email to the other party at that party's address specified hereunder or as communicated in writing to the other party from time to time. Notices shall be deemed to have been given when personally delivered, facsimiled and acknowledged by the recipient or, if given by mail, properly addressed with postage prepaid fourteen (14) days after it is posted.
- 3.1.9.2 All disputes are subject to exclusive jurisdiction of Jaipur Courts only.

#### 4 SPECIAL TERMS AND CONDITIONS OF BID & CONTRACT

#### 4.1 Bidders to Bid for all Items

Bidder must quote for all the items mentioned in the BOQ(Bill of Quantities). In case, a Bidder does not quote for any item, the bid shall be summarily rejected.

#### 4.2 Payment Terms and Schedule

4.2.1 Payment schedule: - Payments to the Contractor, after successful completion of the specified deliverables & related services as per PO, would be made as under: -

- 4.2.3 All remittance charges will be borne by the supplier/ Contractor.
- 4.2.4 Payment in case of those goods which need testing shall be made only when such tests have been carried out, test results received conforming to the prescribed specification.
- 4.2.5 Advance Payment will not be made.

# 4.3 Warranty

Warranty term should be clearly indicated in the offer. Minimum warranty period shall be 24 months from the date of supply & acceptance.

# 4.4 Other Special Terms

- 4.4.1 In case the Bidder fails to supply the final deliverables within stated timelines, the LD as per clause 3.1.7 "liquidated damage" would be applicable.

## 5.10 Form-:F, Annexure-:C Grievance Redressal during Procurement Process

The designation and address of the Second Appellate Authority is **Director** (**O&S**), **JMRC**, **JAIPUR**.

#### (1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under Para(I) shall deal with the appeal as expeditiously as possible and shall Endeavour to dispose it of within thirty days from the date of the appeal.
- (3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

#### (4) Appeal not to be in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) Determination of need of procurement;
- (b) Provisions limiting participation of Bidders in the Bid process;
- (c) The decision of whether or not to enter into negotiations;
- (d) Cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.

#### (5) Form of Appeal

(a) An appeal under para (I) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.

- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

# (6) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

## (7) **Procedure for disposal of appeal**

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
