- INDIA has received financing from the Asian Development Bank (ADB) toward the cost of **Jaipur Metro Rail Line 1-Phase B Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
- Jaipur Metro Rail Corporation (JMRC) (“the Employer”) invites sealed bids from the eligible bidders for the **Supply, Installation, Testing and Commissioning of X-Ray Baggage Scanner Machine, Bullet Proof Morcha, Door Frame Metal Detector and Hand Held Metal Detector with 2 Years of DLP on East-West Corridor of Jaipur Metro (Phase 1B) at Jaipur, Rajasthan, India. - NCB No. - JP/EW/1B/tbd-1.**
- National Competitive Bidding will be conducted in accordance with ADB’s Single – Stage: Single- Envelope bidding procedure and is open to all eligible Bidders as described in the bidding document.
- Only eligible bidders with the following key qualifications should participate in this bidding:

#### 4.1 Qualifying Requirements of Bidders

- The Tenderer/Dealer/supplier shall provide satisfactory evidence acceptable to JMRC to show that:
- (a) Tenderer/Dealer/suppliers should be manufacturer or authorised channel partner of the manufacturer, who regularly manufactures the item required in the tender.
  - (b) The eligible and qualify bidders should participate in this bidding. Please refer to Section 3 (Evaluation and Qualification criteria) of the Bidding Document for the eligibility and qualification.
  - (c) Any tender offering service life of goods less than 10 years from the date of commissioning shall be summarily rejected in the initial stage itself and such offer will not be evaluated further.
  - (d) The bidder shall submit details of eligibility and qualifications in the bidding forms under section - 4 (Bidding Forms). Documentary proof such as completion certificates from client clearly indicating the nature/scope of work, actual completion cost and actual date of completion for such work should be submitted. In case the work is executed for private client, copy of work order, bill of quantities, bill wise details of payment received certified by C.A. for all payments by client shall be submitted.
