2.3.4 Standard Earthing values as per 25KV OHE earthing layout:

- 2.3.4.1 The values of earth resistance of individual pit must be less than or equal to 10 ohm and combined values of earth resistance of each earth station (combined value of all three pits) must be less than or equal to 2 ohm as per IS 3043:1987.
- 2.3.4.2 Date of Measurement of earth resistance, Earth Station Number, Pit Number, Combined Resistance Value of Earth Station, and Resistance Value of Individual Pit must be painted on each Earth Station.

3. Commencement of the Work:

The work should be started within 10 days of issue of LOA and should be satisfactorily completed within Two months of commencement of work.

Payment Terms:
