The letter of authorization from manufacturer in original/ photocopy attested by notary is to be submitted.</b>  <b>OR</b>  <b>(2) The Bidder must have executed any work pertaining to supply of UPS for the MAKE:</b></p>



<p>NUMERIC in any Central Govt. Department /State Govt. Department / PSUs of Central or any state Govt. / Any Metro Rail in India/ Indian Railways or it's PSU during last three financial years and the period ending last day of month previous to the one in which the Bids are invited in current financial year.</p> <p><b>NOTE:</b></p> <ol style="list-style-type: none"><li>1. The works completed here shall mean having successfully physically completion of that particular work.</li><li>2. The Bidder shall attach copy of LOAs / POs/Work Orders along with their work completion certificates issued by the authorized signatory preferably on their letter head of the contract/work awarding agency, mentioning Period of the contract, name of the work and Amount, BOQ. <b><u>For bidders submitting LOA/P.O. of JMRC for work Experience need not to submit Work completion certificates. JMRC will examine the factual details of Work awarded and satisfactory completion of work by firm at time of Bid evaluation.</u></b></li></ol> <p>d) Firm should not have been be blacklisted by Central Government, any State Government or any Government agency or Public sector undertaking (PSU). Firm shall submit an undertaking to this effect as per Form-I: Black list /Termination Undertaking.</p> <p>e) <b><u>POWER OF ATTORNEY (Form: H):</u></b> In case bidder's firm is Partnership/ Company/ Consortium then, a power of attorney to be submitted. The power of attorney is to be signed by the partners or legally authorized signatories of all the partners authorizing the nominated person to be In-charge to sign bid document, incur all liabilities and receive instructions.</p>
<p>At any stage if it is found that bidder has not met any of the above eligibility criteria, his bid will be summarily rejected and action shall be taken as per terms and conditions of this bid documents.</p>
<p><b>Bidder is requested to submit Bank details on letter head of the firm or copy of cancelled cheque of firm at the time of bid submission.</b></p>
