The works completed here shall mean having physically completed that particular work.2. The bidder firm should have work experience of successful completion of Contract related to Supply /Installation/ Testing and Commissioning/ maintenance/ repairing/Non Comprehensive Annual Maintenance Contract /Annual Maintenance Contract of Battery charger of HBL make related work at any Central Govt. Department /State Govt. Department /PSUs of Central or any state Govt./ Any Metro Rail Projects in India/ Indian Railways or it's PSU's/ Autonomous body of Any Govt.3.
