## Terms of Reference (TOR)

**Subject:** Development & Broadcasting of Jaipur Metro Story on DD Rajasthan (Jaipur) programme "**Karambhumi**".

#### 1. OBJECTIVE:

To create customised non-frequency based pre-recorded story to be broadcasted on DD Rajasthan establishment (Programme) and play as programme "**Karambhumi**" for promotional activities of Jaipur metro.

#### 2. TIME SLOT:

#### 3. TERMS & CONDITIONS:

- (i) Scripting, Shooting and Development of one episode of around 11 to 12 minutes on Jaipur Metro.
- (ii) Development of one advertisement with voice over of around 20-25 seconds in consultation with Jaipur Metro.
- (iii) One time broadcast of Episode on Jaipur Metro as Karambhumi programme on DD Rajasthan (6.45 to 7.00 p.m.)
- (iv) Broadcast of JMRC Advertisement for Total on air time of 100 seconds in next 4-5 Episodes of KARAMBHUMI on DD Rajasthan.
- (v) Handling over of the contents of Episode/Advertisement to Jaipur Metro alongwith further broadcast/display rights.
- (vi) Subscription of broadcast certificate of episode and 100 seconds advertisement with invoice to JMRC.
- (vii) JMRC shall provide access to shooting team of M/s Shree Abhiruchi Films in to the Metro Stations and inside Metro Train, provide achievements related literature of Jaipur Metro, brief on the script to the team of M/s Shree Abhiruchi Films, see final version of episode/advertisement and suggest for improvement, if any, before these are telecasted.

#### 4. PAYMENT TERMS:

Payment shall be Released (inclusive of all taxes/levies as applicable), after receipt of broadcast certificate from Doordarshan, content of episode & advertisement along with further broadcast/display rights along with bills.

#### 5. NOTICES:

Any notice, invoice or other communication required or permitted shall be given in writing/ email to the other party at that party's address as communicated in writing to the other party from time to time.

## 6. DISPUTE RESOLUTION:

- (i) Any matter or dispute or difference of whatsoever nature arising under, out of or in connection with this Agreement (collectively "Dispute") between the parties shall be first attempted to be settled by mutual discussions and failing settlement within a month of initiation of the discussion the disputes shall be referred to arbitration to be conducted by a sole arbitrator who shall be appointed by the Managing Director of JMRC and any decision made by the arbitrator shall be final and binding on the parties hereto. The Arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996 and the venue of Arbitration shall be Jaipur. Pending the submission to the arbitration and thereafter, until the Arbitrator publishes his award, the parties shall, except in the event of termination of this agreement, continue to perform all their obligations under this agreement, without prejudice to any final adjustment to be made in accordance with the award of the Arbitrator.
- (ii) All disputes are subject to exclusive jurisdiction of Jaipur Courts only.
