

11. Technical Capability:

- a) Bidder should have valid GST registration or service tax registration certificate issued by competent authority in the State of their operation.
- b) Applicant should have valid PAN certificate/card by the Income Tax Dept. of GOI.
- c) Taxes applicable, if any, will be borne by the bidder.

- 1. All the offers shall be valid for a period of 120 days from the date of closing of auction.
- 2. Bidders have to inspect the material thoroughly and satisfy themselves about the nature, hazardous/explosive properties, if any, before submitting the bid. In case they come across any material beyond the scope of the description of material, it should be informed to JMRC in writing up to scrap material inspection with closing date & time.
- 3. All the materials are offered for sale on "AS IS WHERE IS" basis and where they are stacked. Materials are sold on the assumption that bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complaint shall be entertained in this regard.
- 4. Bidders shall submit Earnest Money of Rs. 500 or 2% of the value of item (whichever is maximum) at the time of auction in cash. The Earnest Money may be given in the form of demand draft of a scheduled bank cheque in favour of "Jaipur Metro Rail Corporation Ltd." payable at Jaipur. Which is refundable.
- 5. All the materials are offered for sale on AS IS WHERE IS basis. The rates shall be offered ON UNIT BASIS FOR EACH TENDER SEPARATELY NOT PART THEREOF i.e. in Rupees per unit only.
- 6. The quantities indicated against the auction are purely indicative subject to a variation of +/- 30%. In the event of quantity turning out to be more than the estimated quantity and within the range of (+) 30% variation, the buyer has to lift the entire material and clear the site after making the required payment. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this ground except the refund of material value for that short quantity from JMRC, Jaipur. The amount of Taxes pertaining to such undelivered quantity shall not be refunded and required to be claimed by the buyer from the respective department only.
- 7. The rates must be announced by bidder exclusive of taxes. Bidders will have to pay the GST as per the applicable rate.
- 8. Bidders shall submit his/their income tax return certificate (latest) partnership deed of organisation.
- 9. The Bidders/customers workmen shall have to abide by the rules & regulation including safety & security regulation of the relevant statutory Acts. Entry inside the Works/stores should only be against Gate pass for the men and equipment for which purchaser will have to apply well in advance before lifting commences.
- 10. The bidder shall ensure that his workmen do not loiter around within the workshop/stores area of JMRC, Jaipur. They shall not touch any material except that material shown to them. If any of his workmen is even found violating this restriction, the bidder shall be responsible for making good the loss to the owners on which their decision shall be final and binding.

11. PAYMENTS TERMS:

The cost of each tender of material along with all taxes and duties must be paid at JMRC by the bidder in equal instalments as per table given below:

After making payment by successful bidder delivery order will be issued by JMRC. For any delay in making payment within the time limit specified, the due payment may be made together with late penalty @1% per day of bidding amount or part thereof on the due amount for the period of delay within 7 days from the due date. However, JMRC reserves the right not to accept the payment with or without the late penalty after the expiry of the above mentioned time limits or even within the aforesaid additional period of 7 days at JMRC sole discretion and in such an event the sale of the tender will be automatically cancelled and the Earnest Money/Security Deposit (as the case may be) will automatically stand forfeited. In between the process if the principal bidder refused to take delivery and want to quit from the process, before making any payment of the auction item, the second highest or subsequent bidder shall be considered.

- 12. LIFTING PERIOD: Material has to be lifted by the bidder by employing their own labour and transport at their own cost within 7 days from the date of auction. If Material not lifted within 7 days, amount submitted by bidder will be forfeited.
- 13. Ground Rent: If the successful Bidder is unable to lift the material within stipulated period as specified in the delivery order, he can request the concerned Store in-charges, in writing, to allow him to lift the material, as a special case, after paying ground rent in advance up to 7 days @ 1% per day of bidding amount or part thereof on the balance un-lifted material value. Tax amount once deposited in Rajya Cosh will not be refunded.
- 14. bidder are required to lift the materials completely on clean sweep basis as to clear site failing which ground rent as applicable will be charged. Quantity indicated in catalogue/tender is only estimated quantity and JMRC shall not compensate for any loss & damages should the actual quantity, be less than estimated quantity.
- 15. The delivery will be given by a delivery committee to be constituted as per JMRC procedure. The delivery shall be made in the joint presence of the bidder and the delivery committee of the JMRC.
- 16. Hazardous Waste: The scrap materials/items which come under the category of Hazardous Waste as per Hazardous Waste (Management & Handling) Act 1989 and Amendment Rule 2002 & 2003 shall be sold only to those buyers who are registered with Ministry of Environment & Forest, GoI/Central Pollution & Control Board.
- 17. Payment towards material value and other dues is to be made as stipulated in the Sale order cum Acceptance letter. If there is a default in payment as per terms of sale order cum Acceptance letter the security deposit mentioned there in will stand forfeited automatically without any further notice.
- 18. The material of all the tenders will be delivered by JMRC on actual Weight/Quantity/Numbers(s) as stated in the auction catalogue tender description. Delivery will be made by JMRC in working day and hours only.
- 19. Before participate in auction the bidder, a presumption would be drawn that the bidder has inspected the material and has satisfied himself about the nature, quantity, quality, other technical specifications, taxes-duties. No complaint, whatsoever, on the points referred above, would be entertained after the submission of the bid.

21. The Principal/Owner of the materials reserves the right to withdraw at any stage the sale of any item or quantity of material either by number or by weight or any other specific unit etc., even after issue of Sale Order/Delivery Order. The Principal/Owner will not be bound to assign any reason or details thereof. Value of the materials so withdrawn, if any and paid by the bidder will be refunded. The principal will however, not be responsible for any damage, loss, direct or consequential compensation whatsoever to the bidder nor for payment of any interest.

22. Ordinary, the highest bidder on the fall of the hammer/up to 3 announcements will be considered as the purchaser, unless the bid is lower than any reserve price that has been fixed or the sale is subject to the approval

of higher authority.
