- 4. The above material shall be delivered at Custody Store, Train Maintenance Depot Bhrigu Path, Mansarovar–Jaipur-302020.
- The rates quoted shall be FoR JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), and transportation charges etc; no other charges shall be paid by JMRC.
- 6. GST will be paid at rate applicable at the time of billing.
- 7. The material is to be supplied within 30 days of issue of purchase order if extension in delivery period is not approved by competent authority.
- 8. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per requirements.
- 9. Tender name, tender no, due date & time should be also be mentioned on the sealed offer.
- 10. Payment Terms-100% payment after receipt and acceptance of material.
- 11.Inspection Authority: BY JMRC representative.

  - 11.2 The firm should have experience of supply of similar items to any metro railways. Necessary documents like PO, proof of supplying shall be submitted by the bidder.
- 12. Consignee: JE/RS/CS, Mansarovar Train Maintenance Depot, Jaipur-Rajasthan.
- 13. The purchaser reserves the right to accept or reject any offer in whole or part without assigning any reason.
- 14. Validity of offer: -Tenderer is required to keep their offer open at least ninety days (90 days) from the date of tender opening.
