## 4. Condition of Contract (Terms of Reference)

#### TERMS OF REFERENCE

## 1. Introduction & Objective of Audit

- 1.1 Jaipur Metro Rail Corporation Ltd. (JMRC), hereinafter referred to **the** "Corporation", is a Special Purpose Vehicle (SPV) formed by Government of Rajasthan, as a wholly owned State Enterprise for execution of the Jaipur Metro Rail Project.
- 1.2 The Corporation has already commissioned Phase 1A from Mansarovar to Chandpole and commercial opening of Phase-IB from Chandpole to Badi Chaupar shall being started on 20.09.2020.
- 1.3 The safety inspection of Phase-1B section has been done on 16-18 March 2020 by Commissioner of Metro Railway Safety, Western Circle, Mumbai and issued the authorization for commencing public carriage of passengers.
- 1.4 Jaipur Metro Rail Project Phase-1B is entirely underground and located in the heritage walled city of Jaipur covering a length of 2.01 km, consisting of two underground stations i.e. Chhoti Chaupar and Badi Chaupar. These station along with the existing operational section of Phase-1A are connected near Chandpole underground stations with 1525.85 m Bored Twin Tunnels (5.80 meter inner dia) arrangement.
- 1.5 Due to the sensitiveness of the tunnelling work, Commissioner of Metro Railway Safety (CMRS) has advised Jaipur Metro to carry out Third Party Audit of tunnelling work from IIT to confirm adequacy of structural strength, integrity, quality of tunnelling works during all adverse condition.
- 1.6 To implement these works, services of experienced Professionals of Indian Institute of Technology (IIT) is required those are capable in getting the work done so that the compliance of CMRS will be submitted.

## 2. Scope of Work and Duties of the Professional:

2.1 The scope of work would include evalution of the design of 2 Nos. Bored Tunnels, field inspection by IIT team and carried out required test to confirm adequacy of structural strength, integrity, quality of tunnelling works during all adverse condition and submitting the Audit report within 2 month of getting clear commercial order from JMRC.

- 2.2 The scope of the work in accordance with these Terms of References (ToR) includes working and maintains close co-ordination at field level so as to ensure consistent and timely execution of work.
- 2.3 Details of 2 Nos. Bored tunnel from Chandpole to Badi Chaupar as under:

Tunnelling work has been carried by erecting pre-cast segmental lining using tunnel boring machine (TBM). The Twin Bored Tunnel are connected with 5 nos. cross passage of 1.2 x 2.1 m. The length of bored tunnel from Chandpole to Chhoti Chaupar is 905.12 m and length of bored tunnel from Chhhoti Chaupar to Badi Chaupar is 620.73 m. The depth of the tunnel invert varies in between 11m to 19m from ground level in the section.

M/s Continental Engineering Corporation, Taiwan has executed the work of tunnel. Omikron Kappa, Greece is the structural design consultant and TBM by Robbins, USA was used for Tunnelling Work. Details of salient features enclosed as Annexure-A.

### 3. Professional Qualifications:

- 3.1 Professional must have vast experience of auditing of Underground Tunnel work on behalf of IIT.
- 3.2 Professional must be a Professor/Faculty of IIT and having Structure/Geotechnical background.

#### 4. Commencement of Work:

4.1 The Professional shall commence his audit work with the date of issue of LOA (Letter of Acceptance) and submitting the Audit Report within 2 Month of LOA (Letter of Acceptance).

#### 5. Financial Proposal

5.1 In preparing the Financial Proposal, the Professional is expected to take into account the requirements and conditions of the TOR. The Professional shall indicate all costs associated with the work, JMRC will not provide any accommodation, expenses for boarding, lodging, travel etc

#### 6. Payment Schedule
