One similar satisfactorily completed work costing not less than the amount equal to 80% of Estimated Cost.</p> <p>b) Annual Turnover: The annual turnover of bidder during each of last three audited financial years should not be less than 40% of the Estimated Cost.</p> <p>c) Definition of similar work:- For consideration as an eligible 'similar work' for the purpose of experience, the listed work shall be considered only if it fulfils any of the following requirements in that work:</p> <p>i. Housekeeping of Administrative or Corporate offices of companies/ govt. Departments.</p> <p>ii. Housekeeping of public campuses like airports, Metro/Mono rail depot/Station, railway stations, five star hotels.</p> <p>iii.
