2. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer.
3. Order will be given to one firm, based on overall lowest rates of items.
4. The above material shall be delivered at Custody Store, Train Maintenance Depot Bhrigu Path, Mansarovar-Jaipur-302020.
5. The rates quoted shall be FoR JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), and transportation charges etc; no other charges shall be paid by JMRC.
6. GST will be paid at rate applicable at the time of billing.
7. The material is to be supplied within 30 days of issue of purchase order if extension in delivery period is not approved by competent authority.
8. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per requirements.
9. Tender name, tender no, due date & time should be also be mentioned on the sealed offer.
10. Payment Terms-100% payment after receipt and acceptance of material.
11. Inspection Authority: BY JMRC representative.
12. Consignee: JE/RS/CS, Mansarovar Train Maintenance Depot, Jaipur-Rajasthan.
13. The purchaser reserves the right to accept or reject any offer in whole or part without assigning any reason.
