

1.1.1.4 THE CONDITIONS OF THIS OBLIGATION ARE:

The EMD/Bid security taken from a bidder shall be forfeited, if any, in the following cases, namely: -

- When the Bidder fails to commence the supply of the goods or service or execute b. work as per supply/ work order within the time specified;
- When the Bidder does not deposit the performance security and failed to signed agreement within specified period after the supply/ work order is placed; and
- If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in the bidding document.
