Bidder has to submit performance report of completed work.</p> <p><b>Note:</b></p> <p>I. <b><u>Bidder is required to submit the details as per Form-K along with supporting documents:</u></b> The Bidder shall attach copy of LOAs / POs/Work Orders along with their work completion certificates issued by the authorized signatory preferably on their letter head of the contract/work awarding agency, mentioning Period of the contract, name of the work and Amount, BOQ. <b><u>For bidders submitting LOA/P.O. of JMRC for work Experience need not to submit Work completion certificates. JMRC will examine the factual details of Work awarded and satisfactory completion of work by firm at time of Bid evaluation.</u></b></p> <p>II. <b><u>Definition of similar works:</u></b></p> <ol style="list-style-type: none"> <li>1. To substantiate the Annual Turnover, Contractor needs to submit the Chartered Accountant (CA) Certificate.</p>
17.	<p><b><u>POWER OF ATTORNEY (Form H):</u></b> In case bidder's firm is Partnership/Company/Consortium then, a power of attorney to be submitted.</p> <p>The power of attorney is to be signed by the partners or legally authorized signatories of all the partners authorizing the nominated person to be In-charge to sign bid document, incur all liabilities and receive instructions.</p>
