Special terms and Conditions:-

1. Technical Specification:

Required material must be as per sample of Head light cover & Tail light cover installed in JMRC RS08 Trains.

- a.) Head light cover (Material- Poly carbonate) should be designed for visibility in day light under normal weather condition at a distance of 300m in front of the train.
- b.) Tail light cover should be designed for visibility in day light under normal weather condition at a distance of 200m behind the train.
- Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and Enclose Copy of GST Registration Certificate.
- 3. Evaluation will be on the basis of lowest rate quoted. Order will be given to one firm, based on overall lowest rates of item.
- 4. The above material shall be delivered at Custody Store Section, Room no. D20, Train maintenance Depot, Bhrigu Path, Mansarovar Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.
- 5. The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), and transportation charges etc; no other charges shall be paid by JMRC.GST will be paid at rate applicable at the time of billing.
- 6. **Delivery Period**: Firm shall supply first 02 nos. of each cover in first lot for trial/approval within 30 days from the date of issue of P.O. after successful trial of cover (first Lot), firm may supply the rest of material within 60 days from date of issue of P.O/ Supply order.

7. Liquidated Damages:

If material not supplied within contract period as mentioned in NIB, then contractor shall be held responsible for liquidated damages. The liquidated damages is compensation of loss on account of late delivery (actually incurred as well as notional) where loss is pre-estimated and mutually agreed to procuring entity may recover from the contractor, as agreed, the liquidated damages a sum equivalent to 0.5 (one half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10(Ten) percent of the value of delayed goods. However decision of procuring entity shall be final in this regard.
