## 1.1 INTRODUCTION

- Jaipur Metro Rail Corporation Limited (JMRC) is a Government of Rajasthan Undertaking, incorporated under the Companies Act, 1956, having its registered office at Admin Building, Mansarovar Metro Train Depot, Bhrigu Path, Mansarovar, Jaipur (Rajasthan) – 302020.
- ii. Jaipur Metro Rail Corporation Ltd. (JMRC) is a wholly owned company of Government of Rajasthan and it was formed to implement and operate the Jaipur Metro Rail Project in Jaipur city. - iii. JMRC desires QR Code facility at JMRC Stations to provide the passengers with non-cash payment facility for buying tickets (Tokens and Smart Cards), Add Value the Smart cards, etc.

As part of this, Jaipur Metro Rail Corporation (JMRC) invites online Bids in two packet system, from reputed, established and financially sound agencies for implementation of QR Codes at JMRC Stations through an open competitive bidding process, for a period of 3 years, in accordance with terms and conditions set forth in this RFP document.
