### SECTION 2

### SCOPE OF WORK

### 2.1 Introduction

- 2.1.1 Jaipur Metro Rail Corporation Ltd. (JMRC) is a wholly owned company of Government of Rajasthan and it was formed to implement and operate the Jaipur Metro Rail Project in Jaipur city. JMRC started its operations on the East-West Corridor from Mansarovar to Chandpole from 03/06/2015, with a total length of 9.63 kms under Phase-IA with eight elevated and one underground station, at approximately one km intervals and Phase 1B, a 2.4 Km stretch from Chandpole to Bari Choupar (underground) started on 28/09/2020.
- 2.1.2 For phase 1-A of JMRC, Radio system was awarded to M/s Cassidian/Airbus and M/s Hytera. The complete radio system consists of various subsystems which are M/s Cassidian/Airbus and Hytera make. It includes DXT3C Switch, Base stations, Train radio system, TCS Server, AKDC, AVLS, Dispatcher and Recorder servers and various types of Communication handset viz. TETRA handsets, RAU, RCP & RCWs. These subsystems are installed at OCC, DCC, stations and Trains for radio communication facility among these locations.
- 2.1.3 Train Radio System is installed in 10 trains for radio communication between trains, OCC, DCC and stations made of M/s Hytera. One pair of Train radio interface unit (TRIU), Train radio control panel (TRCP), Fist Mic, Lifting Handset etc. items are installed in each train. Train Radio antenna already installed on top of Cab Salon in both side and train movement status shown on RCW (Radio Console Workstation). Train Radio must be able to integrate with existing ATC, TIMS, PIS, PA & Rolling stock systems.
- 2.1.4 TRCP:-,The User interface with Radio System is via one main equipment, The TRCP (Train Radio Control Panel). The LCD display on the TRCP is the main place for Radio system to output information to the Driver. TRCP is a single unit installed in Cab Salon for Train operator to use radio feature/keys available on it. The weight of TRCP unit is 2.5 kg and fitment in front side of salon cab of train radio and the dimension as shown in figure 4.2 in bid document.
- 2.1.5 Fist MIC:-Fist Mic is used for voice call as backup usage.
- 2.1.6 Lifting Handset:-Handset is used for normal voice call operation hook- on, hook off without pressing PTT
- 2.1.7 TRIU:- (TRIU) consists of Filter Assembly TCI, Radio and DC-DC converter, 110VDC power supply from rolling stock via 3 pins connector and

then connects to the DC-DC converter for powering TCI And Radio. Major functions of the TRIU is to (1) Interface with Mobile Radio for routing the voice to the required OCC Dispatch Controller. (2) Interface with External Train equipment such as TIC (Train Interface Controller)/ATC, TIMS (Train Information Management System) and PAPIS for on board message display and on board PA call from OCC. (3) Monitor of Train Status and Alarm such as Cabin Occupied, Restricted Mode, and Dead Man Control triggering Signal and transmit this information to the OCC. The weight of TRIU unit is 6.5 kg and fitment in backside of salon cab of train radio and the dimension as shown in figure 4.1 in bid document.

- 2.2 Procurement under the Scope of Work of this RFP covers supply, installation & commissioning & integration of Five (05) no. Complete Train Radio unit (TRIU+TRCP+FIST MIC+ Lifting Handset + Accessories) for Jaipur Metro with One (01) year warranty. Mapping All 10 trains with existing Tetra Systems of Hytera.
- 2.2.1 It shall be the liability of the bidder to maintain the Supplied Train Radio Unit during warranty period for one (01) year and contact/deal with the OEM for all the Service and Support for JMRC during the Contract Period.
- 2.2.2 The Technical Specification of Train Radio Hardware of Current installed Train Radio Unit is mentioned in Volume 2 of this Bid. More details may be provided by JMRC to successful bidder if required. The supplied Train Radio unit and accessories must be fit in the space available in Train Cab and must be compatible with existing Radio communication.

### 2.3 General Conditions:

- 2.3.1 The work is to be carried out as per International Norms/Standards and in such a manner that all premises always look Neat & Clean. Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.
- 2.3.2 All Transport and installation, commissioning, integration & Testing of Train Radio Unit etc required for & corrective maintenance (During Warranty Period) shall be arranged by the contractor. No Transport shall be supplied to contractor by EMPLOYER.
- 2.3.3 JMRC will not provide any hardware/spare part during contract period.
- 2.3.4 The work is to be carried out under the permission of EMPLOYER' representative only.
- 2.3.5 The contract period shall include both hardware and Software support. Remaining Train Sets software also to be upgraded to match new Sets.
- 2.3.6 Software installed in Supplied Train Radio Unit shall have life time validity which shall be purchased on the name of JMRC and the same to be provided to JMRC along with programming cables (2 Set) & tools (Software tool).
- 2.3.7 Proof of Concept (POC) will be demonstrated by the successful firm that the product and service offered in Jaipur Metro is competitive with the existing system. All those demonstrations will be verified by the authorized

representative of JMRC, if it meets the requirements of the specification then final implementation done. If not, it will be rejected.

2.3.8 The other terms & conditions that deems fit to the bidder may be submitted along with the Bid. On review the same; it will be JMRC discretion to include or not to include as the Bid conditions.

## 2.4 Other Terms and Conditions:

- 2.4.1 Minimum warranty period shall be applicable as per NIB.
- 2.4.2 Warranty Period should be clearly mentioned in the handover note and Invoice along with serial no. of the items at the time of supply to JMRC.
- 2.4.3 Loss on Contractor's account: The contractor shall be liable for any loss which JMRC may sustain due to damage to the equipment/ loss of service, on account of omissions/ commissions done by the contractor.
- 2.4.4 The contractor should take necessary measures to cover any loss or damage caused to person or property as a consequence of any action done by the contractor. JMRC shall not be liable for any claims in any such case. Further JMRC shall not be liable for similar, claims on account of the contractor's representatives suffering any loss or damage to person or property. JMRC will not take any responsibility towards insurance and other such liability.
- 2.4.5 Security procedures at JMRC: The contractor personnel will follow all security procedures as prescribed by JMRC from time to time, for entry of personnel or bringing in or taking out material.
- 2.4.6 Risk of Loss or damage to JMRC property: The Contractor shall make sure that no harm or damage is made to JMRC properties and assets while executing the scope of work of this RFP. The performance security/payment shall be forfeited or shall be refunded/made only after making the adjustments for any such damage made by the contractor and his staff.

### 2.5 JMRC staff association:

JMRC shall have the right to associate its personnel with the entire work in all its phases with a view to develop their skills and understanding of systems. The contractor shall provide such personnel with all necessary information and facilities. The fact that some JMRC staff is associated with the contractor shall in no way reduce the responsibility of the contractor in any manner whatsoever.

### 3.1 Bid Prices

### 1.3 Who can Apply

1.3.1 Bidder may apply themselves or in Partnership/Joint Venture/Consortium. Requirements from JV/Consortiumare chalked out in Clause 9.0 below.

### 2.1 All tenders submitted shall include the following information:

The Bidders' names, the presence (or absence) of Cost of Bid Documents/ E-Bid Processing Fee and Bid Security, and other details proposed in covering letter, will be announced by the Bid Opening Committee at the time of opening or same shall be available at the web-site. The bid opening committee will prepare the summary report of bid opening.

### 18.3 PRELIMINARY EXAMINATION OF BIDS

The contents of the technical-bid documents of the individual Bids will be examined summarily in order to assess their formal conformity and agreement with the instructions and guidance to the Bidders and the completeness. Any Bid not conforming to any of these requirements may be disqualified forthwith at the discretion of JAIPUR METRO RAIL CORPORATION.

### 19.0 PROCESS TO BE CONFIDENTIAL

- 19.1 Except the public opening of Bid, information relating to the examination, clarification, evaluation and comparison of Bids and recommendations concerning the award of Contract shall not be disclosed to Bidders or other persons not officially concerned with such process.
- 19.2 Any effort by a Bidder to influence the Employer/Procuring Entity in the process of examination, clarification, evaluation and comparison of Bids and in decisions concerning award of contract, may result in the rejection of the Bidders Bid.

### 20.0 CLARIFICATION OF BIDS

20.1 To assist in the examination, evaluation and comparison of Bids, the Procuring Entity may ask Bidders individually for clarification of their Bids, including breakdowns of prices. The request for clarification and the response shall be in writing or by tele-fax but no change in the price or substance or the Bid shall be sought, offered or permitted.

### 21.0 DETERMINATION OF RESPONSIVENESS

- 21.1 Prior to the detailed evaluation of Bids, the Procuring Entity will determine whether each Bid is responsive to the requirements of the Bid documents.
- 21.2 For the purpose of this Clause, a responsive Bid is one, which conforms to all the terms, conditions and specifications of the Bid documents.
- 21.3 If a Bid is not substantially responsive to the requirements of the Bid documents, it will be rejected by the Procuring Entity, and will not

subsequently be permitted to be made responsive by the Bidder by correction or withdrawal of the non-conformity or infirmity.

The decision of the Procuring Entities to which of the Bids are not 21.4 substantially responsive shall be final.

#### 22.0 EVALUATION OF BID

- 22.1 The Employer will, keeping in view the contents of Clause 1.3 & 8.0 of ITB, carry out technical evaluation of submitted technical proposals to determine that the Bidder has a full comprehension of the work of the contract. Where a Bidder's technical submittal has a major inadequacy, his Bid will be considered to be non-compliant and will be rejected.
- All technically acceptable Bids will be eligible for consideration of their 22.2 financial proposals. The Firms who get technically qualified will be intimated by the Jaipur Metro Rail Corporation. The financial proposal shall be evaluated to determine the lowest bidder (L-1).
- Offers, deviations and other factors, which are in excess of the requirements 22.3 of the Bid documents or otherwise will result in the accrual of unsolicited benefits to the Employer, shall not be taken into account in Bid evaluation.
- Evaluation of financial proposal will be based on pricing schedule/quantities 22.4 in Bill of Quantity (BOQ) and rates quoted. Any alteration in BOQ will not be given any cognizance.
- 22.5The Procuring Entity reserves the right to ask for submission of the source of procurement for the material for which the bidder has quoted his rates before the bid can be considered for acceptance. If the bidder, who is called upon to do so, does not submit within a reasonable time of written order to do so, JAIPUR METRO RAIL CORPORATION shall be at liberty to forfeit the said earnest money absolutely.

#### 23.0 AWARD OF CONTRACT

CRITERIA FOR AWARDING OF TENDER

Subject to Clause 10.3 and 22.0, Procuring Entity will award the contract to 23.1 the Lowest Bidder (L1), whose bid has been determined to be substantially responsive, technically &financially suitable, complete & in accordance with the bid document.

### EMPLOYER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL 24.0 BIDS

Notwithstanding Clause 23.0, the Employer reserves the right to accept or 24.1 reject any Bid, and to annul the Bid process and reject all Bids, at any time prior to award of Contract, or to divide the Contract between/amongst Bidders without thereby incurring any liability to the affected Bidder or Bidders or any obligations to inform the affected Bidders of the grounds for the Employer's action.

### 25.0 NOTIFICATION OF AWARD

- Prior to the expiry of the period of Bid validity prescribed by the Procuring Entity will notify the successful Bidder by E-mail/fax, to be confirmed in writing by registered letter, that his Bid has been accepted. This letter (hereinafter and in the Conditions of Contract called 'the Letter of Acceptance') shall name the sum which the Procuring Entity will pay to the Bidder in consideration of the execution, completion of the works by the Bidder as prescribed by the Contract (hereinafter and in the conditions of Contract called 'the Contract price'). The "Letter of acceptance" will be sent in duplicate to the successful Bidder, who will return one copy to the Procuring Entity duly acknowledged and signed by the authorized signatory, within seven days from the date of issue of LOA by him. No correspondence will be entertained by the Procuring Entity from the unsuccessful Bidders.
- 25.2 The Letter of Acceptance will constitute a part of the contract.
- 25.3 Upon "Letter of acceptance" being signed and returned by the successful Bidder as per Clause 25.1, the Procuring Entity will promptly notify the unsuccessful Bidders and discharge / return their Bid securities.

### 26.0 SIGNING OF AGREEMENT

- The Procuring Entity shall prepare the Agreement in the Performa (Form-D) included in this Document, duly incorporating all the terms of agreement between the two parties. Within 45 days from the date of issue of the letter of acceptance, the successful Bidder will be required to execute the Contract Agreement. The Contract Agreement shall be executed on Rajasthan Stamp duty of Rs. 500/- as per Rajasthan Stamp Act 1998. The performance guarantee should be submitted immediately after issue of letter of acceptance but not later than the agreement is signed between the parties. One copy of the Agreement duly signed by the Procuring Entity and the Bidder through their authorized signatories will be supplied by the Procuring Entity to the Bidder.
- 26.2 Prior to signing of the Contract Agreement, the successful Bidder shall submit the following document within a period of 30 days from the date of issue of the Letter of Acceptance:

### 27.0 PERFORMANCE SECURITY

The Bank Guarantee has to be from a scheduled Commercial Bank based in India and the Form of performance security (Form-C) provided in this Volume shall be used. ### 27.2 Additional Performance Security.

In addition to Performance Security as specified in rule 75, an Additional (1) Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Daft, Banker's Cheque, Government Securities or Bank

Explanation: For the purpose of this rule,-

- 27.3 Failure of the successful Bidder to submit the required performance Security shall constitute sufficient grounds for the annulment of the award of Contract and forfeiture of the Bid Security.

### 28.0 CANCELLATION OF LETTER OF ACCEPTANCE (LOA) & FORM OF BID

In case successful Bidder fails to commence the work (for whatsoever reasons) as per terms & conditions of Bid after issuance of LOA& Letter of commencement then the LOA shall be cancelled and the Bid security shall be forfeited.

### 29.0 CORRUPT & FRAUDULENT PRACTICES

JMRC requires that the Bidders observe the highest standards of ethics during bidding and execution of this contract. In pursuance with this policy, the bidder shall be required to submit their compliance with the code of integrity and no conflict of interest as per Form T-VI.

## 30.0 GRIEVANCE/ REDRESSAL DURING PROCUREMENT PROCESS

### 31.0 QUANTITY VARIATION

JMRC may vary the quantity as per RTPPR Rule-73.

### 32.0 TERMINATION OF THE CONTRACT

- 32.1 If the Contractor fails to carry out any of his obligations, or if the Contractor is not executing the Works in accordance with the Contract, the Engineer may give notice to the Contractor requiring him to make good such failure and remedy the same within such time as the Employer / Engineer may deem to be reasonable.
- 32.2 The Employer shall be entitled to terminate the Contract if the Contractor or any one of its constituents,
  - a) fails to comply with a notice under Sub clause 32.1
  - b) abandons or repudiates the Contract
  - c) without reasonable excuse acceptable to the Engineer, fails to commence the Works in accordance with the Contract
  - d) sub contracts the whole of the Works or assigns the Contract without approval of the Employer
  - becomes bankrupt or insolvent or goes into liquidation except voluntary liquidation for the purpose of amalgamation or reconstruction
  - f)persistently disregards instructions of the Engineer or contravenes any provisions of the Contract, or
  - g) fails to remove materials from the Site, or pull down and replace work, after receiving notice from the Engineer to the effect that the said materials or Works have been condemned or rejected, or
  - h)fails to take steps to employ competent and/or additional staff and labour, or
  - i)fails to afford the Engineer or his representative proper facilities for inspecting the Works or any part thereof, or
  - j)indulges in corrupt or fraudulent practices
  - k)Breach of any of the contract condition during execution.
- 32.2.1 In any one of these events or circumstances, the Employer may upon giving 14 days notice to the Contractor, terminate the Contract and expel the Contractor from the Site. However, in case of sub-paragraph (e) or (j), the Employer may by notice of 7 days terminate the Contract immediately.
- 32.2.2 For the purpose of sub Para (c) above, this clause, reasonable excuse shall be one, which in the opinion of the Engineer has resulted from, Any Circumstance which

- is beyond the employer's or contractor's control and

- made the failure unavoidable and it is evidenced by the Contractor to the satisfaction of the Engineer that the failure was remedied without unreasonable delay once that obstacle was out of the way.
- 32.2.3 The Employer's decision to terminate the Contract shall not prejudice any other rights of the Employer under the Contract.
- On termination of contract due to contractor's default the performance security shall be forfeited by encashing the bank guarantee and the balance work shall be got done independently without risk and cost of the failed contractor. The failed contractor shall be debarred from participating in the tender for executing the balance work. If the failed contractor is a partnership firm, then every member/partner of such partnership firm shall be debarred from participating in the tender for the balance work either in his/her individual capacity or as a partner of any other partnership firm.

- (1) The officer to whom an appeal is filed under Para (I) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it or within thirty days from the date of the appeal.
- (2) If the office designated under Para(1) fails to dispose of the appeal filed within the period specified in Para(2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in Para(2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorised representative.

### (5) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

### (6) Procedure for disposal of appeal

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall,-
  - (i) Hear all the parties to appeal present before him; and
  - (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.

#### Handset Cable Box Mechanical Dimension








