INSTRUCTION TO BIDDERS 2.

Sale of Bidding/ Bid Documents 2.1

- The sale of bidding documents shall be commenced from the date of publication of Notice 2.1.1 Inviting Bids (NIB). The complete bidding documents shall also be placed on the State Public Procurement Portal and JMRC website as per NIB. The prospective Bidders shall download the bidding document from the specified website(s) and pay its bid cost on or before while submitting the bid to the procuring entity.
- The bidding documents shall be made available to any prospective Bidders who pays the Bid 2.1.2 cost for bank demand draft, banker's cheque Bid documents cost is not refundable.

2.2 Cost of bid document and Bid Security/EMD

- Bid security shall be 2% of the estimated value of subject matter of procurement put to bid. 2.2.3
- The Bid Security of unsuccessful Bidders shall be refunded soon after final acceptance of 2.2.4 successful bid and submitting performance security.
- The Bid Security taken from a bidder shall be forfeited, including the interest, if any, in the 2.2.5 following cases, namely: -
- when the bidder withdraws or modifies its bid after opening of bids; a.

- Issue of LOA for procurement and performance security is furnished by the successful b. Bidder;
- the cancellation of the procurement process; or C.



The withdrawal of bid prior to the deadline for presenting bids, unless the bidding d. documents stipulate that no such withdrawal is permitted.

2.3 Changes in the Bidding Document

- At any time, prior to the deadline for submission of Bids, the procuring entity may for any reason, whether on its own initiative or as a result of a request for clarification by a Bidder, modify the bidding documents by issuing an addendum in accordance with the provisions below.
- In case, any modification is made to the bidding document or any clarification is issued which 2.3.2 materially affects the terms contained in the bidding document, the procuring entity shall publish such modification or clarification in the same manner as the publication of the initial bidding document.
- In case, a clarification or modification is issued to the bidding document, the procuring entity 2.3.3 may, prior to the last date for submission of Bids, extend such time limit in order to allow the bidders sufficient time to take into account the clarification or modification, as the case may be, while submitting their Bids.

2.4 Period of Validity of Bids

- Bids submitted by the Bidders shall remain valid during the period specified in the NIB/ 2.4.1 bidding document. A Bid valid for a shorter period may be rejected by the procuring entity as non-responsive Bid.
- Prior to the expiry of the period of validity of Bids, the procuring entity, in exceptional 2.4.2 circumstances, may request the Bidders to extend the bid validity period for an additional specified period of time. A Bidder may refuse the request and such refusal shall be treated as withdrawal of Bid and in such circumstances Bid Security shall not be forfeited.

2.5 Format and Signing of Bids

- The Bidder shall prepare one original set of the bidding documents called Bid in the manner as 2.5.1 specified in the bidding document information
- All pages the bid of shall be signed by the Bidder or a person duly authorized to sign on behalf 2.5.2 of the Bidder, in token of acceptance of all the terms and conditions of the bidding documents. This authorization shall consist of a written confirmation as per "Certificate of Conformity/ No-Deviation" of the bidding document and shall be attached to the technical bid. Any corrections in the bid such as interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the bid.

2.6 Sealing and Marking of Bids

The bids shall be submitted as described below.

The bids shall be submitted in Two Sealed Envelopes (Envelope 1 and Envelope 2) marked as Cover: 1st and Cover: 2nd respectively. Both the cover should be separated and they should be enclosed in another common Envelope (3rd cover). Name of work, Name of bidder and Jast date of receipt of bids should be mention on each Envelope.



The Envelope 1 shall contain the following:

- 2.6.1.1.1 Bid Cost and Bid Security: Bid cost and Bid security shall be enclosed as Para 2.2 of Bid Document.
- 2.6.1.1.2 Power of Attorney: In accordance with relevant clause and authorization for executing the power of attorney as per clause 17 of NIB. (Form H) (If applicable).
- 2.6.1.1.3 Corrigendum: Any Corrigendum / Amendment issued up to last date / time of submission of NIT & Uploaded / Posted on website.
- 2.6.1.1.4 Check list as per clause 8.0.

In case, Envelope 1 is not annexed or bid cost, EMD etc. not found in proper form, the Envelope 2 containing bid documents will not be opened at all.

The Envelope 2 (Cover: 2nd) marked as "SECOND COVER FOR THE WORK OF (NAME OF WORK)" should contain: Eligibility criteria, bid documents containing terms and conditions, specifications, schedule of quantities etc. complete as original bid documents got issued from JMRC or downloaded from the internet. The rates and amounts should be filled only in the BOQ (schedule of quantities) attached thereto. The bidder shall enclose duly signed and stamped, copy of the Bid Document, documents supporting eligibility criteria and the Financial Bid (BOQ).

Bids, signed without any of the information desired in the prescribed formats will not be considered. Besides this all other associated / required documents shall be submitted duly numbered and signed/ stamped by the bidders.

2.7 Cost & Language of Bidding

- The Bidder shall bear all costs associated with the preparation and submission of its Bid, and 2.7.1 the procuring entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- The Bid, as well as all correspondence and documents relating to the Bid exchanged by the 2.7.2 bidders and the procuring entity, shall be written only in English/ Hindi Language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages in English/ Hindi language, in which case, for purposes of interpretation of the Bid, such translation shall govern.

Alternative/ Multiple Bids 2.8

Alternative/ Multiple Bids shall not be considered at all. 2.8.1

Deadline for the submission of Bids 2.9

Bids shall be received, by the person, designated for the purpose, by the procuring entity or 2.9.1 directly dropped in the bid box, at the place and up to the time and date specified in the NIB.

Late Bids 2.10

The person authorized to receive the bids shall not receive any bid that is submitted 2.10.1 personally, after the time and date fixed for submission of bids.





2.10.2 Any bid, which arrives by post after the deadline for submission of bids, shall be declared and marked as "Late" and returned unopened to the Bidder.

2.11 Receipt and Custody of Bids

- 2.11.1 The bids shall be received by hand delivery, by courier or by post in the specified format up to the specified time and date and at the specified place, by the person authorized by the procuring entity.
- 2.11.2 The person authorized to receive the bids shall provide a receipt signed by him with date and time of receipt of bid to the person, who delivers the bid.
- 2.11.3 All bids received unsealed, in torn or damaged condition through post or by personal delivery shall be so marked and signed on the cover by the person receiving the same and get signed on it by the person delivering it and put in a fresh cover and reseal, if so warranted. All such entries shall be attested by the receiving person.
- 2.11.4 The received bids shall be kept in safe custody in lock and key by the person authorized to receive the bids.
- 2.11.5 The location of bid box shall be such as to facilitate easy access to Bidders.
- 2.11.6 Bids received by the authorized person on or before the time and date fixed for receipt of bids shall be entered in bids receipt register and the same shall be closed at the scheduled time and date giving in words and figures the number of bids received up to the last time and date for submission of bids.
- 2.11.7 The record of bids received late through post shall be entered in bids receipt register after closing the register as per above.
- 2.11.8 Bids received by telegram or given on form other than the prescribed form shall not be considered.

2.12 Withdrawal, Substitution, and Modification of Bids

- 2.12.1 A Bidder may withdraw, substitute, or modify its bid after it has been submitted by sending a written Notice, duly signed by an authorized signatory, and shall include a copy of the authorization. The corresponding substitution or modification of the bid must accompany the respective written Notice. All Notices must be:
 - a. Submitted in accordance with the bidding document, and in addition, the respective envelopes shall be clearly marked "Withdrawal," "Substitution," "Modification"; and
 - b. Received by the procuring entity prior to the deadline prescribed for submission of bids.
- 2.12.2 Bids requested to be withdrawn shall be returned unopened to the Bidders.
- 2.12.3 No bid shall be withdrawn, substituted, or modified in the interval between the deadline for submission of bids and the expiration of the period of the specified bid validity or any extension thereof.



Opening of Bids 2.13

- 2.13.1 The sealed bid box shall be opened by the bid opening committee constituted by the procuring entity at the time, date and place specified in the bidding document in the presence of the Bidders or their authorized representatives, who choose to be present.
- 2.13.2 The bids receiving person shall also hand over all the bids received by him up to the time and date for submission of bids to the Convener of bids opening committee and obtain its signature in the bids receipt register.
- 2.13.3 The bid opening committee may co-opt experienced persons in the committee to conduct the process of bid opening.
- 2.13.4 The bids shall be opened by the bids opening committee in the presence of the Bidders or their authorized representatives who choose to be present. All envelopes containing bids shall be signed with date by the members of the committee in token of verification of the fact that they are sealed. The envelopes shall be numbered as a/n, where 'a' denotes the serial number at which the bid envelop has been taken for opening and 'n' denotes the total number of bids received by specified time.
- 2.13.5 The bid opening committee shall prepare a list of the Bidders or their representatives attending the opening of bids and obtain their signatures on the same. The list shall also contain the representative's name and telephone number and corresponding Bidders' names and addresses. The authority letters brought by the representatives shall be attached to the list. The list shall be signed by all the members of bid opening committee with date and time of opening of the bids.
- 2.13.6 Bids should always be placed in sealed envelope, in the manner detailed in Para 2.6 will be received and opened on the due dates by committee.
- 2.13.7 Envelope 1 (Cover 1st) enclosing the Bid Security, Bid cost etc. [As per clause 2.6.1.1.1] shall be opened on the scheduled date and time.
- 2.13.8 In case Envelope 1 is not annexed with bid cost, EMD, etc. or not found in acceptable form, the Envelope 2 containing eligibility criteria, bid documents will not be opened at all and such unopened bids shall be returned on spot to the bidder or his representative during the process of opening of bids/ or by through post, as the case may be. The bid cost deposited for issue of bid documents/Demand Draft along with downloaded bid shall not be refunded, if bidder is found ineligible.
- 2.13.9 Envelope 2 (Cover: 2nd) containing eligibility criteria and bid documents complete as original shall be opened on the scheduled date and time of bid opening if found eligible as per Envelope 1.
- 2.13.10 After the opening of Envelope 2 of eligible bidders, the bid documents containing terms & conditions, specifications and Bill of quantities (BoQ) etc. shall be evaluated by JMRC.
- 2.13.11 If it is found at any stage of bid evaluation after submission of bid that the bidder has made any correction/addition/alternation/omission in bid documents vis-a-vis bid documents available on the website/original draft NIB in office, the bid shall be treated as non-responsive





and shall be summarily rejected and the EMD deposited by bidder shall be forfeited in addition to any other action as per prevalent rules.

- 2.13.12 Envelopes shall be opened one at a time and the following details shall be read out and recorded:
 - the name of the Bidder and whether there is a substitution or modification;
 - the bid prices (per lot if applicable); b.
 - the Bid Declaration Form C.
 - Any other details as the committee may consider appropriate. d.
- 2.13.13 After all the bids have been opened, they shall be initialed and dated on the first page of the each bid by the members of the bids opening committee. All the pages of the price schedule and letters, Bill of Quantities attached shall be initialed and dated by the members of the committee. Key information such as prices, delivery period, etc. shall be encircled and unfilled spaces in the bids shall be marked and signed with date by the members of the committee. The original and additional copies of the bid shall be marked accordingly. Alterations/ corrections/ additions/ over-writings shall be initialed legibly to make it clear that such alteration, etc., were existing in the bid at the time of opening.
- 2.13.14 No bid shall be rejected at the time of bid opening except the late bids, alternative bids (if not permitted) and bids not accompanied with the proof of payment or instrument of the required price of bidding document, processing fee (if any) or user charges and Bid Security.

Selection Method 2.14

- The selection method is Least Cost Based Selection (LCBS) as detailed below: 2.14.1
- Single bid system ,bid will be opened on scheduled time and date as per NIB. The contract 2.14.1.1 will be award to most advantageous bidder of financial bid.
- Bidder shall quote price for each job /items types and job/items sub-types. 2.14.1.2
- The ranking of L1, L2, L3 etc., will be done on basis of Total Cost, with L1 being the bidder 2.14.1.3 whose Total Cost is the lowest, L2 being the second lowest and so on.
- The contract will be award to most advantageous responsive bidder of financial bid subject 2.14.1.4 to fulfillment of eligibility criteria.
 - The Contract/LOA shall be awarded to only One Bidder. 2.14.2

Clarification of Bids 2.15

- To assist in the examination, evaluation, comparison and qualification of the Bids, the bid 2.15.1 evaluation committee may, at its discretion, ask any Bidder for a clarification regarding its Bid. The committee's request for clarification and the response of the Bidder shall be in writing.
- Any clarification submitted by a Bidder with regard to its Bid that is not in response to a 2.15.2 request by the committee shall not be considered.



- No change in the prices or substance of the Bid shall be sought, offered, or permitted, 2.15.3 except to confirm the correction of arithmetic errors discovered by the committee in the evaluation of the financial Bids.
- No substantive change to qualification information or to a submission, including changes 2.15.4 aimed at making an unqualified Bidder, qualified or an unresponsive submission, responsive shall be sought, offered or permitted.
- All communications generated under this rule shall be included in the record of the 2.15.5 procurement proceedings.

Evaluation & Tabulation of Bids 2.16

Preliminary Examination of Bids 2.16.1

- The bid evaluation committee constituted by the procuring entity shall conduct a preliminary 2.16.1.1 scrutiny of the opened bids to assess the prima-facie responsiveness and ensure that the:
 - bid is signed, as per the requirements listed in the bidding document; a.
 - bid has been sealed as per instructions provided in the bidding document; b.
 - bid is valid for the period, specified in the bidding document; c.
 - Bid is accompanied by bidding document fee, Bid Security. d.
 - bid is unconditional and the Bidder has agreed to give the required performance security; e.
 - Other conditions, as specified in the bidding document are fulfilled. f.

Determination of Responsiveness 2.16.2

- The bid evaluation committee shall determine the responsiveness of a Bid on the basis of 2.16.2.1 bidding document and the provisions of pre-qualification/ eligibility criteria of the bidding document.
- A responsive Bid is one that meets the requirements of the bidding document without any 2.16.2.2 material deviation, reservation, or omission where: -
 - "deviation" is a departure from the requirements specified in the bidding document; i.
 - "reservation" is the setting of limiting conditions or withholding from complete acceptance ii. of the requirements specified in the bidding document; and
 - "Omission" is the failure to submit part or all of the information or documentation required iii. in the bidding document.
- A material deviation, reservation, or omission is one that, 2.16.2.3
 - if accepted, shall:-İ.
 - affect in any substantial way the scope, quality, or performance of the subject matter of 1. procurement specified in the bidding documents; or
 - limits in any substantial way, inconsistent with the bidding documents, the procuring entity's 2. rights or the Bidder's obligations under the proposed contract; or
 - if rectified, shall unfairly affect the competitive position of other Bidders presenting ii. responsive Bids.



- The bid evaluation committee shall examine the technical aspects of the Bid in particular, to 2.16.2.4 confirm that all requirements of bidding document have been met without any material deviation, reservation or omission.
- The procuring entity shall regard a Bid as responsive if it conforms to all requirements set 2.16.2.5 out in the bidding document, or it contains minor deviations that do not materially alter or depart from the characteristics, terms, conditions and other requirements set out in the bidding document, or if it contains errors or oversights that can be corrected without touching on the substance of the Bid.

2.16.3 Non-material Non-conformities in Bids

- The bid evaluation committee may waive any non-conformity in the Bid that does not 2.16.3.1 constitute a material deviation, reservation or omission, the Bid shall be deemed to be substantially responsive.
- The bid evaluation committee may request the Bidder to submit the necessary information 2.16.3.2 or document like GST certificate, Pan Certificate, etc. within a reasonable period of time. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
- The bid evaluation committee may rectify non-material nonconformities or omissions on the 2.16.3.3 basis of the information or documentation received from the Bidder under above.
- Bids shall be evaluated based on the documents submitted as a part of bid. Bidders are 2.16.3.4 expected to quote for all the items. Similarly, in case the proposal of a Bidder is nonresponsive for any item, the Bidder shall be summarily rejected.
- The evaluation shall include all costs and all taxes and duties applicable to the Bidder as per law of the Central/ State Government/ Local Authorities, and the evaluation criteria 2.16.3.5 specified in the bidding documents shall only be applied;
- The offers shall be evaluated and marked L1, L2, L3 and so on. L1 being the lowest offer 2.16.3.6 quoting least value of 'Total Cost in financial bid. A list of L1, L2....will be prepared accordingly.
- The rates quoted by L1 Bidder shall be accepted as the bid rates. 2.16.3.7
- In case of exceptional high rate for any item/sub activity, negotiation shall be held with L1 firm on the quoted rate of respective item/sub activity. In case of failure of negotiation, rate 2.16.3.8 contract for that particular item shall not be entered into.
- The members of bid evaluation committee shall give their recommendations below the table 2.16.3.9 regarding lowest bid or most advantageous bid and sign it.

Correction of Arithmetic Errors in Financial Bids: 2.17

- The bid evaluation committee shall correct arithmetical errors in substantially responsive 2.17.1 Bids, on the following basis, namely: -
- if there is a discrepancy between the unit price and the total price that is obtained by 2.17.2 multiplying the unit price and quantity, the unit price shall prevail and the total price shall be





- corrected, unless in the opinion of the bid evaluation committee there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- if there is an error in a total corresponding to the addition or subtraction of subtotals, the 2.17.3 subtotals shall prevail and the total shall be corrected; and if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to clause (2.17.1.2) and above.

Price/ purchase preference in evaluation: 2.18

Price and/ or purchase preference notified by the State Government (GoR) and as 2.18.1 mentioned in the bidding document shall be considered in the evaluation of Bids and award of contract.

Negotiations 2.19

- Negotiations may, however, be undertaken with the lowest Bidder when the rates of any job 2.19.1 type are considered to be much higher than the prevailing market rates or the rates quoted for that job type by other bidders.
- The bid evaluation committee shall have full powers to undertake negotiations. Detailed 2.19.2 reasons and results of negotiations shall be recorded in the proceedings.
- The lowest Bidder shall be informed in writing either through messenger or by registered 2.19.3 letter and e-mail (if available). A minimum time of seven days shall be given for calling negotiations. In case of urgency the bid evaluation committee, after recording reasons, may reduce the time, provided the lowest or most advantageous Bidder has received the intimation and consented to regarding holding of negotiations.
- Negotiations shall not make the original offer made by the Bidder inoperative. The bid 2.19.4 evaluation committee shall have option to consider the original offer in case the Bidder decides to increase rates originally quoted or imposes any new terms or conditions.
- In case of non-satisfactory achievement of rates from lowest Bidder, the bid evaluation 2.19.5 committee may choose to make a written counter offer to the lowest Bidder and if this is not accepted by him, the committee may decide to reject and re-invite Bids or to make the same counter-offer first to the second lowest or most advantageous Bidder, then to the third lowest or most advantageous Bidder and so on in the order of their initial standing and work/ supply order be awarded to the Bidder who accepts the counter-offer. This procedure would be used in exceptional cases only.
- In case the rates even after the negotiations are considered very high, fresh Bids shall be 2.19.6 invited.

Acceptance of the successful Bid and Issuance of Letter of Acceptance 2.20

The procuring entity after considering the recommendations of the bid evaluation committee and the conditions of Bid, if any, financial implications, trials, sample testing and 2.20.1 test reports, etc., shall accept or reject the successful Bid. If any member of the bid





- evaluation committee has disagreed or given its note of dissent, the matter shall be referred to the next higher authority, as per delegation of financial powers, for decision.
- Decision on Bids shall be taken within original validity period of Bids and time period allowed 2.20.2 to procuring entity for taking decision. If the decision is not taken within the original validity period OR time limit allowed for taking decision, the matter shall be referred to the next higher authority in delegation of financial powers for decision.
- Before issuance of Letter of Acceptance (LOA) the procuring entity shall ensure that the price 2.20.3 of successful Bid is reasonable and consistent with the required quality.
- A Bid shall be treated as successful only after the competent authority has approved the 2.20.4 procurement in terms of that Bid.
- The Bid Security of the Bidders who's Bids could not be accepted shall be refunded soon 2.20.5 after the contract with the successful Bidder is signed and its performance security is obtained.

Procuring entity's right to accept or reject any or all Bids 2.21

The Procuring entity reserves the right to accept or reject any Bid, and to annul (cancel) the 2.21.1 bidding process and reject all Bids at any time prior to award of contract, without thereby incurring any liability to the Bidders as per RTPP Act and Rules.

Right to Vary Quantity 2.22

- Right to vary Quantity will be governed as per Rule 73 of RTPPR, 2013. 2.22.1
- Orders for extra items may be placed upto 5% of the value of the original contract. The fair 2.22.2 market value of such extra items payable by the JMRC to the contractor shall be determined by the JMRC in accordance with guidelines prescribed by the administrative department
- Orders for additional quantities may be placed, on the rates and conditions given in the 2.22.3 contract and Delivery or completion period may also be proportionately increased. The limits of orders for additional quantities shall be as under :-
 - (a) 50% of the quantity of the individual items and 50% of the value of original contract in case of works; and
 - (b) 50% of the value of goods or services of the original contract.

Performance Security Deposit 2.23

Prior to execution of work order, Performance security shall be solicited from all successful 2.23.1 Bidder except the departments of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them. The State Government may relax the provision of performance security in particular procurement or any class of procurement.



- The successful bidder shall be required to deposit an amount mentioned in NIB of this bid 2.23.2 document as performance security after issue of LOA/P.O.
- Performance Security will be discharged after completion of bidder's performance 2.23.3 obligations including warranty obligations under the contract.
- If the bidder fails or neglects any of his obligations under the contract, JMRC reserve the 2.23.4 right to forfeit performance security furnished by the bidder as penalty for such failure.
- 2.23.5 The successful bidder shall be required to deposit an amount equal to 5 % of the amount of Contract value and required to be submitted within the time period governed with RTPPR, 2013 respective clause.
- Performance security shall be furnished in any one of the following forms: -2.23.6

 - If the Bidder breaches any provision of code of integrity, prescribed for Bidders, specified in C. the bidding document.
 - Notice will be given to the Bidder with reasonable time before Performance Security 2.23.8 deposited is forfeited.
 - No interest shall be payable on the Performance Security Deposit. 2.23.9
 - In addition to performance security, an Additional Performance Security in rule 75, an 2.23.10 Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump





sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Daft, Banker's Cheque, Government Securities or Bank Guarantee or electronic bank guarantee (e-BG).

Subject to the order of precedence set forth in the Agreement, all documents forming the 3.1.1.1 Contract (and all parts thereof) are intended to be correlative, complementary, and mutually explanatory.

Scope of Work 3.1.2

Subject to the provisions in the bidding document and contract, the execution of complete 3.1.2.1 scope of work shall be executed as per Letter Of Acceptance (LOA)/Purchase Order.

Delivery/ (completion of work) 3.1.3

- If national holiday is being declared on bid due date then bid will be opened on next suitable 3.1.3.1 working day.
- The Contractor shall complete within the stipulated time period. 3.1.3.2
- Bidders shall be asked to supply the items as per specification within the specified delivery/ 3.1.3.3 completion period at designated places within Jaipur and across the State of Rajasthan and the details of supply/ shipping and exact locations where the items need to be supplied shall be specified in the purchase order and/ or contract.
- The Supplier/ Selected Bidder shall arrange to supply the ordered materials as per 3.1.3.4 specifications in bid document.

Recoveries from Supplier/ Contractor 3.1.4

Recovery of liquidated damages, short supply, defects, rejected shall be made ordinarily 3.1.4.1 from bills or Performance Security Deposit (as the case may be).



- The Purchase Officer shall withhold amount to the extent of short supply, broken/ damaged or for rejected Electrical Consumables and in case of failure in satisfactory replacement by 3.1.4.2 the supplier along with amount of liquidated damages shall be recovered from his dues and Bid Security available with the department.

 - Wherever references are made in the Contract to codes and standards in accordance with which it shall be executed, the edition or the revised version of such codes and standards 3.1.5.2 shall be those specified in the work order. During Contract execution, any changes in any such codes and standards shall be applied only after approval by the Purchaser and shall be treated in accordance with the general conditions of the contract.

Inspection 3.1.6

The Purchase Officer or his duly authorized representative shall at all reasonable time have access to the supplier's/ Contractor's premises and shall have the power at all reasonable 3.1.6.1 time to inspect and examine the materials and workmanship of the goods/ equipment/ machineries during manufacturing process or afterwards as may be decided.

Rejection 3.1.7

- Articles not approved during inspection or testing shall be rejected and will have to be replaced by the Contractor at his own cost within the time fixed by the Purchase Officer. 3.1.7.1
- If, however, due to exigencies of work, such replacement either in whole or in part, is not considered feasible, the Purchase Officer after giving an opportunity to the Contractor of 3.1.7.2 being heard shall for reasons to be recorded, deduct a suitable amount from the approved rates. The deduction so made shall be final.

Liquidated Damages (LD) 3.1.8

Termination 3.1.9

Termination for Default 3.1.9.1

- 3.1.9.1.1 The bid sanctioning authority of JMRC may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least 30 days sent to the supplier/ Contractor, terminate the contract in whole or in part: -
 - If the supplier/ Contractor fails to deliver any or all quantities of the service within the time a. period specified in the contract, or any extension thereof granted by JMRC;

- If the supplier/ Contractor, in the judgment of the Purchaser, is found to be engaged in c. corrupt, fraudulent, collusive, or coercive practices in competing for or in executing the
- If the supplier/ Contractor commits breach of any condition of the contract. d.
- If JMRC terminates the contract in whole or in part, amount of Performance Security Deposit 3.1.9.2 may be forfeited.

Note: In addition to the conditions specified above, the approved GCC are applicable and available on the JMRC website. The successful bidder shall submit a declaration for acceptance of the terms and conditions mentioned the GCC (clause 6.5 Form E (j) }.



SPECIAL TERMS AND CONDITIONS OF BID & CONTRACT 4

4.1 Bidders to Bid for all Items

4.2 Payment Terms and Penalty

- Advance Payment will not be made. 4.2.1
- Payment schedule: 100% of total value of actual work executed and accepted (as per P.O. / 4.2.2 LOA). The bidder should submit Tax Invoice after completion of work and work completion service report duly signed by nominated JMRC Staff.
- Due payments will be made promptly, after submission of an invoice or request for payment 4.2.3 by the supplier/ Contractor, and the purchaser has accepted it.
- The currency or currencies in which payments shall be made to the supplier/ Contractor under 4.2.4 this Contract shall be Indian Rupees (INR) only.
- All remittance charges will be borne by the supplier/ Contractor. 4.2.5
- If bidder fails to submit performance security, execution of contract within specified time, no 4.2.6 payment shall be made for the work, if any done after issuance of LOA/PO.

4.3 Warranty/DLP period:

The minimum warranty period of 12V, 100AH VRLA Zero Maintenance Battery mentioned in Part A, Sr. No. 5 of BOQ, is twenty four months from the date of commissioning. And for the rest, the minimum warranty period of spares and servicing work executed is six months from the date of commissioning.

4.4 Other Special Terms

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:
