
NOTICE INVITING BIDS

- 9. Bidder must quote for all the items mentioned in the BOQ (Bill of Quantities). In case, a Bidder does not quote for any rate of any item, the bid shall be summarily rejected.
- 10. JMRC reserves the right to accept or reject any or all proposals without assigning any reasons.
- 11. No Bid shall have any cause of action or claim against the JMRC for rejection of his proposal.
