Input Volt –AC230V (50 Hz) (normal) between AC 219V and AC 242V, 36W Linear Fluorescent Tube, Tube type:- Length: 1200mm, Lumen:2450Lm, Colour Temp:6500K, Super Bright.
2. Required material should be strictly as per specification mentioned.
3. Acceptable Make: Crompton Greave/equivalent and ISI marked.
4. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and Enclose Copy of GST Registration Certificate.
5. Evaluation will be on the basis of lowest rate quoted. Order will be given to one firm, based on overall lowest rates of item.
