Special terms and Conditions:-

Annexure -A

- 1. Required material should be strictly as per descriptions mentioned in annexure- B.
- 2. **Testing & suitability**: Technical specifications of the item will be confirmed by doing physical visual inspection, measurement and fitment in train at JMRC Metro depot.
- 3. Material Technical Specification: Required item's dimensions must be as per sample i.e. (a) Inside Diameter: 3.3 mm (approx). (b) Outside Diameter: 6.5 mm (approx). (c) Number of coils per spring: 10 in no. (d) Other details/design: As per sample. Bidder may advised to visit JMRC depot to take the required sample.
- 4. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and enclose Copy of GST Registration Certificate.
- 5. All pages of RFQ shall be signed by the bidder or a person duly authorized to sign on behalf of bidder, in token of acceptance of the terms & conditions of the RFQ documents.
- 6. Order will be given to one firm, based on overall lowest rates of item.
- 7. The above material shall be delivered at Custody Store Section, Room no. D20, Train maintenance Depot, Bhrigu Path, Mansarovar –Jaipur-302020 to JE/Custody Store, Cont. no. 07728895713.
- 8. The rates quoted shall be For JMRC office, Mansarovar Metro Depot, Jaipur-302020, inclusive of all expenses i.e. all taxes (excluding GST), and transportation charges etc; no other charges shall be paid by JMRC. GST will be paid at rate applicable at the time of billing.
- 9. Delivery Period: The firm shall supply first 10 nos. of torsion springs in first lot for fitment trial/approval within 30 days from the date of issuing of purchase order. After successful trial of torsion spring (first lot), firm may supply the rest of material within 60 days from the date of issuing of purchase order if extension in delivery period is not approved by competent authority.
- 10.Liquidated Damage: The liquidated damages is compensation of loss on account of late delivery (actually incurred as well as notional) where loss is pre-estimated and mutually agreed to procuring entity may recover from the contractor, as agreed, the liquidated damages a sum equivalent to 0.5(one half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10(Ten) percent of the value of delayed goods. However decision of procuring entity shall be final in this regard. The offer shall be unconditional and duly signed.



- 11.Warranty: Minimum 18 months from the date of supply of material or 12 months from the date of fitment whichever is earlier.
- 12. The quantity of material may increase/decrease up to a certain limit (up to 25%) as per JMRC requirements and RTPPR-2013.
- 13. Tender name, tender no, due date & time should be also be mentioned on the sealed offer.
- 14.Payment Terms: 100% payment after receipt and acceptance of material.
- 15.Inspection Authority: By JMRC representative.
- 16.**Rejection**: Materials not approved during inspection or testing shall be rejected and will have to be replaced by the Contractor at his own cost within the time fixed by the Purchase Officer.

- 18. The purchaser reserves the right to accept or reject any offer in whole or part without assigning any reason.
