- 4. Grease CAN should be properly packed with no damage and sealed. The "Make" and "Product Name" should be confirm.
- 5. Offer from the firms who do not have a valid GST No. will not be entertained. GST No. Should be clearly indicated in offer and enclose Copy of GST Registration Certificate.
- 6. All pages of RFQ shall be signed by the bidder or a person duly authorized to sign on behalf of bidder, in token of acceptance of the terms & conditions of the RFQ documents.
- 7. Order will be given to one firm, based on overall lowest rates of item.
