1. India has received financing from the Asian Development Bank (ADB) toward the cost of **Jaipur Metro Rail Line 1-Phase B Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. **Jaipur Metro Rail Corporation Limited (JMRC)** (“the Employer”) invites sealed bids from the eligible bidders for the “**Design, Manufacture, Supply, Installation, Testing & Commissioning of Telecommunications System for Phase 1B of Jaipur Metro Rail Project (Choti Chouper – Badi Chouper Underground Section)**”.
