No Bidder shall have any cause of action or claim against the Jaipur Metro Rail Corporation for rejection of his proposal.

Minimum Eligibility criteria :- The bidder should meet all the eligibility 1.3 criteria as mentioned below:-

- (a) Initial Requirements:-The bidder should have not been debarred either by procuring entity or State Govt. in pursuance to the process of debarment specified in RTPPR, 2013. Firm shall submit an undertaking to this effect as per Form-P.
- (b) Work Experience :- (Physical requirement)
  - The participating firm should have experience in the field of supply/Annual maintenance of Radio System (viz. base stations, tetra communication etc.)in Railways, Metros/ Government Ministries/ Departments/ PSUs/Private Ltd. (SEBI listed companies).
  - Bidder should have valid GST registration certificate issued by ii. competent authority and shall enclose GST certificate along with bid submission.
  - Bidder should have valid PAN certificate/ card issued by the Income iii. Tax Dept. of GOI and enclose PAN certificate.
  - Copy of Registration certification of the firm / partnership deed / iv. Certificate of incorporation. Etc.

### (c) Financial Standing (Annual Turnover):

The average annual turnover of bidder during last three audited financial years (2020-21, 2021-22& 2022-23) should not be less than Rs. 1,22,80,000/- (40% of estimated cost). To substantiate the Annual Turnover, Contractor needs to submit the Chartered Accountant (CA) Certificate.

- NOTE:-Turnover for the financial year 2022-23 can be considered if the accounts are audited and certified by Chartered Accountant or attach Balance Sheet for respective years as a proof of document. In any case three consecutive financial year's turnover will be considered.
- (d) The Bidder should keep in consideration positive variation in BOQ permitted as per GCC and RTPPR-2013. Bidder should be able to take up additional similar work at short notice at the accepted rate for which he has to allocate his additional resources. #### SECTION 2

## SCOPE OF WORK

### 2.1 Introduction

- 2.1.1 Jaipur Metro Rail Corporation Ltd. (JMRC) is a wholly owned company of Government of Rajasthan and it was formed to implement and operate the Jaipur Metro Rail Project in Jaipur city. JMRC started its operations on the East-West Corridor from Mansarovar to Chandpole from 03/06/2015, with a total length of 9.63 kms under Phase-IA with eight elevated and one underground station, at approximately one km intervals and Phase 1B, a 2.4 Km stretch from Chandpole to Badi Choupar (underground) started on 28/09/2020.
- 2.1.2 The contractor will execute the work of Comprehensive Annual Maintenance Contract for 5 years for Radio System (Cassidian/Airbus make) installed at 9 metro stations & OCC under S&T (O&S) of Jaipur Metro Rail Corporation Ltd. The following system installed under S&T department of JMRC will be included in CAMC:

- 2.1.3 The existing JMRC TETRA Network (as mentioned above) is an Cassidian/AIRBUS TETRA system release 6.0 (R6) which is to be upgraded on Release 8.0 (R8)/latest. JMRC will provide these above mentioned System for the upgradation purposes in Non-Revenue Hours.
- 2.1.4 Half yearly maintenance of the equipment listed at Table-1 which shall be done onsite and include Airbus Remote as well as Technical support. After maintenance summary report signed with contractor and JMRC shall be submitted to JMRC

- 2.1.5 If any faulty systems or devices are identified during or before the half yearly maintenance then it shall be repair/replaced under CAMC. If spares are available with JMRC it can be utilised for maintenance, but the same shall be replaced with new supply by the bidder within 3 months to JMRC.
- 2.1.6 The bidder should submit a declaration from OEM included in MAF (Manufacturer's Authorization Form) that in case of any hardware failure OR software upgrade/application installation in other hardware, the existing license should work. In case it won't work then OEM will support JMRC for existing OR new license (without any cost) installation in the radio equipments covered under this CAMC. The bidder shall submit MANUFACTURER'S AUTHORIZATION FORM (MDF) in the form-M.
- 2.1.7 Tetra Terminal will be programmed by JMRC under the supervision of Support engineer provided by the contractor, but tool for programming with updated software is to be provided by the bidder and training of programming terminal is to be done by the bidder.
- 2.1.8 JMRC will not be responsible for custom clearance, Import Export Formalities, shipping, transport etc. JMRC only can share the details of existing licence of the Radio Terminal used in JMRC.
- 2.1.9 All active and passive component of the Airbus/Cassidian Radio System are included under this CAMC and not limited to the only component mentioned at Table-1 of Scope of Work.
- 2.1.10 JMRC available spare parts can be used during CAMC but same new part shall be handed over to JMRC within time specified under contract. JMRC spare utilisation decision is under sole discretion of JMRC. JMRC will decide to handover their spare depending upon the situation arises.
- 2.1.11 Server (IT related only) hardware are already under the another CAMC executed by JMRC, but to resolve any failure or during Software upgradation, if hardware upgrade will be required then the cost of the same is to be borne by the bidder.
- 2.1.12 Contractor shall provide a support Engineer at Jaipur only and will be available in general duty hours from 09:30 Hrs to 17:30 Hrs. This engineer can be called during night shift in case of any emergency or other requirement.
- 2.1.13 Site access shall be provided by JMRC as and when required for failure resolution and maintenance.
- 2.1.14 JMRC will provide remote connection as and when required by the bidder to resolve a failure or for any required purposes.
- 2.1.15 General Maintenance/cleaning will be executed by JMRC under the supervision of Support engineer provided by the contractor.
- 2.1.16 Half Yearly Maintenance will be executed by the Contractor team onsite at JMRC and system will be thoroughly audited during this maintenance. Contractor shall submit the detailed Audit report to JMRC after the maintenance has been done.
- 2.1.17 Since the operating system installed at Radio System (Airbus/Cassidian) are out-dated and it is Bidders responsibility to

provide Operating System support on their own at the time of any failure.

### 2.2 Site visit for CAMC

i. The Bidders are advised to visit the site for health check-up the system mentioned in the scope of work and obtain all information that may be necessary for preparing the offer of CAMC for filling in the BOQ(as per NIB). No visit charge will be paid by JMRC and visit date is mentioned in NIB.

ii. The Bidders are also advised to visit and examine the site of works and its surroundings at his/their own cost and obtain all information that may be necessary for preparing the offer of CAMC for filling in

the BOQ.

# 2.3 Comprehensive Annual Maintenance:

The contractor will execute the work of Comprehensive Annual Maintenance Contract for 5 years for Radio System (Cassidian/Airbus make) installed at 9 metro stations & OCC under S&T (O&S) of Jaipur Metro Rail Corporation Ltd. as per manufacturer recommendations.

I. All modules including every consumable (except Batteries) are to be supplied by the contractor during the duration of the contract. All T&Ps, Testing instruments etc required for preventive & corrective maintenance shall be arranged by the contractor. No T&P shall be supplied to contractor by JMRC. In case of emergency, if JMRC spares are used by the contractor then the same new spare shall be handed over to JMRC within specified time period.

II. In case of replacement of any defective part during maintenance these component/PCBs/Modules/Parts should be of the same specifications or equivalent. Also, the Contractor shall submit an undertaking that Radio System(Airbus/Cassidian) performance & all other technical parameters have remained unaffected after rectification &

maintenance work.

III. No space for stocking of spare parts of bidder will be provided by JMRC.

IV. The Contractor during the Execution of work shall follow the Indian Electricity Rules, Indian Electricity Act & all other Statutory Rules, Regulations & Acts as available on date & during the period of contract.

V. The contractor has to maintain a register for the periodical maintenance and repair, which have to be jointly signed with representative of the JMRC as a token of witnessing the same, and the contractor representative.

VI. The contractor should depute only qualified / experienced engineer.

(24\*7 days) for carrying out the preventive, corrective and Breakdown maintenance work. He shall report at Communication System supervisor during general duty shift.

VII. The Maintenance and servicing report shall be submitted in triplicate, which shall be signed by Contractor and JMRC representatives. The Contractor will submit report-giving details of Preventive, Corrective and Breakdown Maintenance carried out.

### 2.4 Preventive Maintenance: -

1) Half yearly Maintenance is to be carried out as per the approved schedule during non-revenue hours under proper Permit to Work (PTW) in such a manner that overall functioning of the system & function of equipment's will not get affected.

2) Contractor during every Preventive Maintenance ( Half Yearly) shall submit a Detailed Audit report signed by Contractor and JMRC representatives to JMRC.

3) Half Yearly preventive maintenance will include but not limited to and any other checks as per OEM prescribed maintenance manual.

#### 2.5 Corrective Maintenance: -

- 1. The corrective/breakdown maintenance is to be carried out any time inclusive of all Sundays & Holidays during the contract period. 24x7 Hrs onsite support as and when required.
- 2. The Employer expects the Contractor should provide 24×7 call centre with toll free numbers and escalation matrix at 3 levels.
- 3. In case of any failure/fault, initially JMRC will look after the issue and try to rectify the same, if failure still persists; a complaint will be logged through call/mail for which a complaint ticket no. will be issued. The ticket number will be tracking reference for both parties till the closure of failure/fault.

4. Response time to attend any failure/breakdown of the Radio system shall not exceed as per mentioned in Minor Corrective Maintenance & Major Corrective maintenance.

- 5. In case of breakdown of one Base station (TB3) and/or loss of redundancy availablein the modules/sub-system/system covered under CAMC, corrective maintenance will be carried out in night on the same date during non-revenue hours (23:00 Hrs. to 04:00 Hrs.). The rectification time shall be as per 2.5.8 & 2.5.9.
- 6. In case of DXT3 breakdown or Network not available due to failure of any other modules/sub-system/system covered under CAMC, corrective maintenance will be carried out immediately and the maximum time to restore the Radio System for the JMRC shall not exceed 4 hours (inclusive of response time).
- 7. For the faulty repaired items, following reports will be submitted by the contractor to JMRC :-
- Report having description of fault diagnosed
- · List of the parts which are replaced / repaired
- · Testing & service sheets after repairing.
- 8. Minor Corrective Maintenance: Inclusive of Repairing and Replacement of all Spares/Components and all other associated accessories which are covered otherwise and attention of all defects other than major defects.
  - Response and attending Time (Max) -04 hours i.
  - Rectification Time (Max.) --48 hours (inclusive of response time) ii.
- 9. Major Corrective Maintenance: Major failures/breakdowns are described as in which the Radio Network is not available at one or multiple sites, communication is non-functional.
  - Response and attending Time (Max) -01 hours i.
  - Rectification Time (Max.) --04 hours (inclusive of response time) ii.
- Call made before 15:00 Hrs. shall have to be attended on same day.

The request for clarification and the response shall be in writing or by tele-fax but no change in the price or substance or the Bid shall be sought, offered or permitted.

#### DETERMINATION OF RESPONSIVENESS 21.0

- For the purpose of this Clause, a responsive Bid is one, which conforms to all 21.2 the terms, conditions and specifications of the Bid documents.

  - a) fails to comply with a notice under Sub clause 32.1

  - c) without reasonable excuse acceptable to the Engineer, fails to commence the Works in accordance with the Contract
  - d) sub contracts the whole of the Works or assigns the Contract without approval of the Employer
  - e) becomes bankrupt or insolvent or goes into liquidation except voluntary liquidation for the purpose of amalgamation or reconstruction
  - f)persistently disregards instructions of the Engineer or contravenes any provisions of the Contract, or
  - g) fails to remove materials from the Site, or pull down and replace work, after receiving notice from the Engineer to the effect that the said materials or Works have been condemned or rejected, or

h)fails to take steps to employ competent and/or additional staff and labour, or

i)fails to afford the Engineer or his representative proper facilities for inspecting the Works or any part thereof, or

j)indulges in corrupt or fraudulent practices

k)Breach of any of the contract condition during execution.

- In any one of these events or circumstances, the Employer may upon giving 14 days notice to the Contractor, terminate the Contract and expel the Contractor from the Site. However, in case of sub-paragraph (e) or (j), the Employer may by notice of 7 days terminate the Contract immediately.
- 32.2.2 For the purpose of sub Para (c) above, this clause, reasonable excuse shall be one, which in the opinion of the Engineer has resulted from, Any Circumstance which
  - is beyond the employer's or contractor's control and
  - made the failure unavoidable and it is evidenced by the Contractor to the satisfaction of the Engineer that the failure was remedied without unreasonable delay once that obstacle was out of the way.
- 32.2.3 The Employer's decision to terminate the Contract shall not prejudice any other rights of the Employer under the Contract.
- On termination of contract due to contractor's default the performance security shall be forfeited by encasing the bank guarantee and the balance work shall be got done independently without risk and cost of the failed contractor. The failed contractor shall be debarred from participating in the tender for executing the balance work. If the failed contractor is a partnership firm, then every member/partner of such partnership firm shall be debarred

#### Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issues there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (1) The officer to whom an appeal is filed under Para (I) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it or within thirty days from the date of the appeal.
- (2) If the office designated under Para(1) fails to dispose of the appeal filed within the period specified in Para(2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in Para(2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

## (3) Appeal not to Be in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) Determination of need of procurement;
- (b) Provisions limiting participation of Bidders in the Bid process;
- (c) The decision of whether or not to enter into negotiations;
- (d) Cancellation of a procurement process;

## (4) Form of Appeal

- (a) An appeal under Para (I) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorised representative.

## (5) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second' appeal shall be rupees ten thousand, which shall be non-refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

## (6) Procedure for disposal of appeal

- (a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall,-
  - Hear all the parties to appeal present before him; and
  - (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal.
