1. SCOPE OF WORK AND SITE CONDITIONS

- 1.1 The scope of work includes checking the performance of RO System and submitting a report after every visit. Scope of work include: unit check-up and general cleaning, chemical cleaning of cartridge, if required, replacement of membrane, as per the complaint during the AMC Period.
- 1.2 In case of any complaint/ breakdown/fault in any equipment, the firm has to attend the fault within 48 hours of reporting on phone/FAX/ Email/SMS etc. failing which will invite a penalty as follows:
 - a. Attending to complaint between 48 hours — 5 days of intimation- Rs. 50/- per day
 - b. Attending to complaint between 5 days to 10 days of intimation- Rs. 100/- per day
 - c. Attending to complaint beyond 10 days - Rs. 150/- per day
- 1.3 The AMC is for preventive as well as for break down maintenance and includes repair and replacement of the following parts free of charge during the AMC Period:-
 - a) All kinds of Filters
 - b) Pre-Carbon filter
 - c) Post-Carbon filter
 - d) PP filter
 - e) Send filter
 - f) Membrane
 - g) Pump with motor
 - h) SMPS
 - i) Low pressure switch
 - j) Over flow switch
 - k) Pipes(All types)
 - l) SV(Solenoid Valve)
- 1.4 Free replacement of consumables such as all kinds of Filters, membranes etc. are mandatory at least one time in a year. Contractor are therefore submit one set of all kind of filters, membrane etc every year to the JMRC custody store, which will be issued by custody store to the contractor for repair of Water purifiers during AMC.
- 1.5 AMC period includes repair of the all electrical and mechanical parts provided for the RO Plants including replacement of parts and rewinding as and when required.
- 1.6 The contractor shall maintain TDS level of output of Water purifiers below 75 PPM.

2. TERMS AND CONDITIONS OF THE CONTRACT

- 2.1 The JMRC reserves the right to accept or reject any or all quotations without assigning any reason.
- 2.2 The rates to be quoted for the period of two year of AMC at respective columns as specified in BOQ (Annexure 'B').
- 2.3 Quarterly visits are mandatory during the contract period of two years and additional visit as and when required, due to complaint in R.O. system.
- 2.4 No payment in advance shall be considered. Payment will be made on quarterly basis after satisfactory services report by the JMRC nominated staff. No extra charges will be paid for attending the complaint.

- 2.5 The repair of equipment should be done as per schedule failing which JMRC reserves the right to get any other authorized party to service the machine and the cost if any in such cases will be recovered from firm.
- 2.6 Bidders are requested to quote their most competitive rate in "Bill of Quantities" given at Annexure "B".
- 2.7 Prices should be inclusive of all taxes, transportation, free services and replacement of all components as and when required to maintain the quality of drinking water.
- 2.8 No bidder shall be allowed to revise its original price.
- 2.9 The validity of the quotation should be 90 days from the last date of the submission.
- 2.10 Before quoting the rate, bidder may visit the site to judge the conditions.
- 2.11 The RFQs/offers shall not add any conditions. In case, conditions are included in the quotation, the same may not be taken into consideration. The offers in such cases are liable to be rejected. Clarification, if any, shall be obtained in writing from the RFQ inviting authority before submission of the quotation.
- 2.12 Incomplete and unsigned quotations are liable to be rejected.
- 2.13 At the end of the period of AMC, all machines under AMC will be handed over as functional machine.
- 2.14 The Registration Number of the firm along with GST No, should be enclosed with the RFQ document.
- 2.15 The contractor has to maintain a register for the periodical inspections, which have to be signed by representative of the JMRC. The contractor should depute only qualified/experienced technicians for carrying out the preventive maintenance work.
- 2.16 The AMC shall be for two years and the JMRC reserves the right to enter into AMC for another one year on the same terms and conditions depending on the services rendered by the bidder and mutual consent of the firm.
- 2.17 The AMC shall be in force for the period of two years from the date as mentioned in the letter of award.
- 2.18 The Bidder shall submit RFQ in a sealed envelope containing all necessary documents such as GST registration certificate with duly signed quotation.
- 2.19 No bids will be received/ accepted after the expiry of the prescribed date and time for submission of the bids. Postal delay or loss of tender in transit will not be the responsibility of Jaipur metro rail corporation.
